Overview

Darboy Sanitary District: We have begun personally inspecting the exterior grease trap at Burger King because of a lack of response by Sanimax and Burger King corporate, coupled with our inability to gain entrance into the stores because of Covid. One reminder letter is required and 4 site visits will be conducted.

Village of Combined Locks: There were no significant issues, related to the FOG Control Program, in April. Two reminder letters are required and no site visits will need be conducted`.

Village of Kimberly: There were no significant issues, related to the FOG Control Program, in April. Two reminder letters are required and three site visits will be conducted.

Village of Little Chute: The Burger King Restaurant in the Village shut down. We are awaiting a status report from the cleaning contractor that maintains Piggly Wiggly grease trap. Four reminder letters are required and 3 site visits will be conducted.

City of Kaukauna: Heirloom Kitchen Co. moved to Little Chute. Kindred Hearts was thought to be closed, but cleaned their grease trap in April. A total of 2 reminder letters are required and 6 site visits will need to be conducted.

Summary of Site Visits & Correspondence

Uno's, Red Robin, Stoneyard, SALT, China Garden, Mac's/Pizza Ranch, Thai Sushi, Ban Vinai, Walmart and Novo Grande: On or around April 15, 2022, the grease traps or downstream manholes for all of the above-named locations were checked. With the exception of Stoneyard, all of the grease traps or manholes were in good condition. The Stoneyard is currently closed and for sale and the trap would need to be cleaned prior to any resumption in operations.

Mac's Macaroni and Cheese: On April 26, 2022, we talked to the store manager at Mac's and were told that Sanimax was there in early April but did not leave a service slip. They will contact Sanimax and try to get a copy for us.

Burger King: Receiving no response from corporate and unable to enter the building because of Covid, we manually checked the exterior trap at Burger King and found it had been recently cleaned. Sanimax is their cleaning vendor and both Sanimax and Burger King Corporate have been difficult to get any confirmations from. If this trend continues, we will put the site on the manual check list.
