HOVMSD FOG Control Program Update

June 2022

Overview

Darboy Sanitary District: The newly constructed multi-store commercial buildings in Darboy now have exterior grease interceptors. While we still have issues with the individual sites in getting their traps cleaned, we can visually monitor the building's exterior trap to make sure any lapses in cleaning do not adversely impact the municipal sewer system. Two reminder letters are required and 3 site visits will be conducted.

Village of Combined Locks: There were no significant issues, related to the FOG Control Program, in June. No reminder letters are required and 1 site visit will need be conducted`.

Village of Kimberly: Mader's Catering has resumed operations and we are currently trying to meet up with management to get them back on a cleaning schedule. El Agave is now open and we met with management to introduce the FOG Control Program and set them up on a cleaning schedule. No reminder letters are required and two site visits will be conducted.

Village of Little Chute: There were no significant issues, related to the FOG Control Program, in the Village in June. One reminder letter is required and 1 site visit will be conducted.

City of Kaukauna: We finally verified the cleaning of the Trinity Lutheran grease trap. We are setting up a meeting with the managers at JJ'S Wine Bar to verify they do not have food service and get a feel for their long-term goals, regarding food service and how that may impact their need to install a grease trap in the future. A total of 5 reminder letters are required and 3 site visits will need to be conducted.

Darboy Joint Sanitary District #1 Grease Trap Inspections Summary Report June 30, 2022

Summary of Site Visits & Correspondence

Uno's, Red Robin, Stoneyard, SALT , China Garden, Mac's/Pizza Ranch, Thai Sushi, Ban Vinai, Walmart and Novo Grande: On or around June 14, 2022, the grease traps or downstream manholes for all of the above-named locations were checked. With the exception of Uno's and Stoneyard, all of the grease traps or manholes were in good condition. Uno's and The Stoneyard are currently closed and the traps would need to be cleaned prior to any resumption in operations.

Starbucks, Panera Bread, Papa Murphy's and Jersey Mikes: In May we talked to managers of the stores listed and asked for their grease trap cleaning documents. Jersey Mikes was the only facility that responded back. A subsequent investigation of the two properties discovered that both were served by exterior grease interceptors as well as the individual grease traps that each business had. On June 14, 2022, we inspected both interceptors and found then to be in very good condition. While we will continue to push for the individual sites to supply us with their cleaning documents, we now have the ability to field verify that the businesses minimizing the grease entering the municipal sewer system.

Firehouse Subs: On June 14, 2022, we talked to the store manager of Firehouse Subs about their responsibilities under the FOG Control Program. We set them up on a 6-month cleaning schedule and will monitor its effectiveness over time.
