Overview

Darboy Sanitary District: There were no significant issues, related to the FOG Control Program, in July. Four reminder letters are required and 4 site visits will be conducted.

Village of Combined Locks: There were no significant issues, related to the FOG Control Program, in July. No reminder letters are required and no site visit will need be conducted`.

Village of Kimberly: The Two Buck Bar has had an exterior grease trap that was a carryover from their days as a Wendy's Restaurant. The owners are looking to abandon the trap as part of a facility expansion, which may include adding limited food service. Our recommendation was that they install an interior trap and work with the Village on the permitting and logistics of abandoning the exterior one. Two reminder letters are required and 2wo site visits will be conducted.

Village of Little Chute: There were no significant issues, related to the FOG Control Program, in the Village in July. Two reminder letters are required and 2 site visits will be conducted.

City of Kaukauna: We manually checked the exterior grease trap at Arby's and determined that the trap was in good condition and did not warrant immediate cleaning. Store management could not verify if this was because it was cleaned recently or because they are producing less grease. We again asked for their latest trap cleaning documents and management passed our request on to corporate. A total of 3 reminder letters are required and 2 site visits will need to be conducted.

Summary of Site Visits & Correspondence

Uno's, Red Robin, Stoneyard, SALT, China Garden, Mac's/Pizza Ranch, Thai Sushi, Ban Vinai, Walmart and Novo Grande: On or around July 8, 2022, the grease traps or downstream manholes for all of the above-named locations were checked. With the exception of Uno's, all of the grease traps or manholes were in good condition. Uno's is currently closed and the trap would need to be cleaned prior to any resumption in operations.

Dunkin Donuts: On July 17, 2022, we stopped by Dunkin Donuts to check the exterior trap. Cones were placed on the covers and an employee indicated that they were there in anticipation of the cleaning contractor's arrival. We will verify the cleaning in August.

Summary of Site Visits & Correspondence

Two Buck Bar: On July 18, 2022, we received a phone call from the owner of the Two Buck Bar asking for guidance in abandoning their exterior grease trap to facilitate patio renovations. We were unaware that a trap existed until he pointed out that the facility was formerly a Wendy's Restaurant. They are thinking of adding limited food service and we recommended that they install an interior trap on their sanitation system before exploring the options of abandoning the exterior trap. We also noted that any work or alterations would require the approval of the local inspectors and/or public works department. He said he would take this under advisement and let us know how they wished to proceed.

Maders Catering: Over the course of the month, we stopped by Maders Catering several times and left several messages on their voicemail. If we don't hear back in August, we will ask for authority to placard the building as non-compliant.

Wildfire Cafe: Having received no response after our June site visit, we again visited Wildfire on July 26, 2022. We talked to a manager who indicated that the trap had not been cleaned and she would schedule the cleaning immediately and forward the documents to us.
