## **ORDINANCE NO.1717**

## ORDINANCE ANNEXING LAND FROM THE TOWN OF VANDENBROEK TO THE CITY OF KAUKAUNA FOR TOM DERCKS

WHEREAS, a Petition for Direct Annexation signed by all owners of land within such territory, has been filed with the Clerk/Treasurer of the City of Kaukauna together with a scale map and a legal description of the property to be annexed showing the boundaries of such territory and the relation of the territory to the municipality to which annexation is requested. and

WHEREAS, notice of the proposed annexation was served upon the State of Wisconsin Department of Administration (Petition File Number 13892) and said Department determined that the proposed annexation is not against the public interest, and

WHEREAS, there has been due compliance with all requirements of Section 66.0217 of the Wisconsin State Statutes, and

WHEREAS, the property is being annexed for purposes of providing municipal services; and

WHEREAS, the matter was acted upon by the City Plan Commission which recommended annexation of the property;

NOW, THEREFORE, the Common Council of the City of Kaukauna do ordain as follows:

That the particular property hereinafter described pursuant to the Petition filed with the Clerk/Treasurer of the City of Kaukauna be, and the same is, hereby annexed to the City of Kaukauna, and the same is hereby detached, by operation of law, from the Town of Vandenbroek, Outagamie County, Wisconsin. That the territory so annexed is known and described as follows:

Part of Government Lot 2 located in Section 14, Township 21 North, Range 18 East, Town of Vandenbroek, Outagamie County, Wisconsin, containing 165,913 square feet (3.8089 acres) of land more or less, including all lands between the described meander line and the centerline of an intermittent stream, described as follows:

Commencing at the Northwest Corner of Private Claim 1, Section 21, R18E; thence along the Northwesterly line of said Private Claim 1, N49° 42'04'E, 335.56 feet to the North line of the City of Kaukauna; thence along said North line, N89 33'40"W, 65.00 feet to a meander point being N89 · 33'40"W, 21 feet more or less from the centerline of an intermittent stream, said point also being the point of beginning; thence continuing along said North line, N89° 33'40"W, 1306.49 feet; thence N68° 46'01"E, 131.74 feet; thence N17° 40'41"E, 90.41 feet; thence S89° 33'40"E, 1178.41 feet to a meander point being S89 33'40"E, 21 feet more or less from the center line of a navigable stream; thence along a meander line S09 20'23"W, 136.65 feet to the point of beginning.

Said parcel contains 165,915 +/- square feet of land or 3.8089 acres, more or less, and is subject to all easements and restrictions of record.

FURTHER, BE IT RESOLVED by the Common Council of the City of Kaukauna that the City of Kaukauna shall pay and the Clerk/Treasurer is directed to pay to the Treasurer of the Town of Vandenbroek, beginning with property taxes for the year 2015 and continuing through the year 2019, an equal amount to the property taxes that the town levied on such annexed territory, as shown by the tax roll under Section 70.65 Wisconsin Statutes for the year 2014.

This ordinance shall be in full force and effect from and after its adoption.
