

**PUBLIC NOTICE OF LANGUAGE CHANGES  
TO  
HEART OF THE VALLEY  
METROPOLITAN SEWERAGE DISTRICT  
PRETREATMENT PROGRAM**

**PLEASE TAKE NOTICE:** A Public Hearing regarding the said Language Changes to the HOV Sewer Use Ordinance shall be held at 6:00PM on March 8, 2016 at the Heart of the Valley Metropolitan Sewerage District Administration Building. The location of which is at the east end of Thilmany Road, 801 Thilmany Road, Kaukauna, Wisconsin 54130.

Listed below are language changes that must be adopted to the HOVMSD Sewer Use Ordinance resulting from revising the Municipal Pretreatment Program Streamlining Changes in Chapter NR 211, Wisconsin Administrative Code enacted in February 2014.

Language Changes are as follows;

**ARTICLE II DEFINITIONS**

SEC. 2.01 Unless the context specifically indicates otherwise, the following terms and phrases, as used in this Ordinance, shall have the meanings hereinafter designated:

- (5) “Authorized Representative of User” shall mean the following:
- (a) A president, secretary, treasurer, or vice president in charge of a principal business function, or any other person who performs similar policy or decision making functions, if the User is a corporation.
  - (e) The manager of one or more manufacturing facilities, provided the manager is authorized to make decisions which govern the operation of the facility, make major capital investment recommendations, initiate and direct comprehensive measures to assure long-term compliance with environmental laws, can ensure the necessary systems are established to gather complete and accurate information for the report and where authority to sign documents has been delegated to the manager according to the corporation’s procedures.

**ARTICLE V - CONTROL OF WASTEWATER DIRECTED TO HOVMSD FACILITY**

SEC. 5.01 SUBMISSION OF BASIC DATA

- (3) All Significant Industrial Users shall obtain a Wastewater Discharge Permit pursuant to Article XIV below.

## ARTICLE XIV - ADMINISTRATION OF SEWERAGE SYSTEM AND INDUSTRIAL DISCHARGE

### SEC. 14.02 APPLICATION INFORMATION

(11) A written plan or other action to control Slug Loadings.

### SEC. 14.04 PERMIT CONDITIONS

(11) Requirements for effluent limits, including best management practices, based on prohibited discharge standards, categorical pretreatment standards, local limits and state and local law;

(12) Requirements to control Slug Loadings, if so determined by the Director to be necessary in its sole discretion;

(13) Requirements for notification of Slug Loadings as provided for in Section 14.13, below; and notification of any changes at the facility described in the permit which affect the potential for a slug discharge and the need for a slug control plan.

### SEC. 14.12 PERIODIC COMPLIANCE REPORTS

(6) The Director shall require frequency of monitoring that is necessary to assess and assure compliance by the Permit User with applicable Categorical Pretreatment Standards and Pretreatment Requirements. In addition, the Director shall require the Permit User to satisfy the requirements of NR 211.15(1)(d) and (e) and (4), Wis. Admin. Code, to the extent applicable to the discharges authorized in the permit. Any Significant Industrial User who is not subject to categorical pretreatment standards shall conduct samples and submit reports in accordance with the provisions of NR 211.15(5), Wis. Admin. Code.

If sampling performed by a Permit User indicates a violation, the Permit User shall notify the Director within twenty four (24) hours of becoming aware of the violation.

(8) In addition, the Permit User shall submit to the District all reports required under NR 211.15(4)(a), Wis. Admin. Code, as and when required.

(9) All reports required to be submitted pursuant to this Section 14.12 shall be retained in the manner and for the time periods provided for in NR 211.15(8)(c), Wis. Admin. Code.

(10) If sampling performed is performed by the District, the District may require the Permit User to follow the repeat sampling and analysis requirements pursuant to NR 211.15(7), Wis. Admin. Code.

(11) SIU will notify HOV on any changes in their facility (Process or otherwise) that may change its operations and therefore need to be reevaluated if a "Slug Discharge Control Plan" may be required to be added to its permit requirements.
