Glen,

Thank you again for speaking with me yesterday. I am emailing to request any documents/prints/plans/specifications/etc detailing the construction/renovation/addition work at the Heart of the Valley Wastewater Treatment Plant during the 1980's. My specific inquiry is when the construction took place, and what pipe material was used. Any assistance is appreciated and my office is prepared to pay associated costs.

Please advise if the following summary of our conversation yesterday is accurate – Heart of the Valley was established in 1972. The existing Kaukauna plant was utilized as the districts sewerage treatment plant. Between approximately 1976 – 1979, a major construction/overhaul/renovation was performed at the Kaukauna location. Between 1979 and the middle 1990's, no construction/renovation/addition work was performed at the treatment plant. In the late 1990's asbestos insulation/wrap was removed from the pipes running through the plant. Asbestos cement pipe was not installed during the construction period 1976 – 1979, or any point thereafter.
