We are pleased to submit our proposal for the Biostyr Stairwell Repair Project located at your facility in Kaukauna, Wisconsin. This proposal is per our jobsite walk through on May 6, 2016.

Our proposal is based on the following items:

- > Remove existing asphalt 5' from existing building and remove from site.
- Excavate (2) sides of building to below existing footing.
- > Install (5) resistance piers down to bedrock and lift to practical recovery.
- Backfill, compact and replace asphalt with new 4000psi concrete reinforced with #4 rebar.
- > Remove existing caulk at joints and replace with new.
- > Remove damaged masonry block as necessary and replace with new. (Matching color cannot be guaranteed)
- > If additional work is requested outside of this proposal, the cost will be tracked on a Time and Material Basis and the amount will be increased accordingly.
- Electrical, Piping, Fire Protection, HVAC, Roofing, Hazardous Material Removal, Painting, Engineering, Permits and Flooring are not included.

We propose to furnish all construction materials, supervision, labor, construction equipment and all other required services to complete this project for the FIRM PRICE of NINETEEN THOUSAND SEVEN HUNDRED EIGHTEEN DOLLARS AND NO/100 (\$19,718.00).
