Hi Dave,

The influent gate to Actiflo train # 1 has failed. The gate has slid down to a position of approximately 90 % closed, and can't be moved. This renders that Actiflo train un-useable, reducing facility treatment capacity by 50%.

Kevin has contacted three contractors and is requesting bids to bypass pump flows from the grit removal channel, around the Actiflo influent channel, and into the # 2 Actiflo train. They then will need to dewater the influent channel, descend into the channel and check and repair the gate as necessary. If repairs are not immediately possible, we would have them raise the gate and secure it in place. Then return and repeat the process once they have the required gate repair/replacement equipment and materials.

This maintenance/repair can't wait. We need the treatment capacity should we receive any significant rain events.

I will contact you once we receive the quotes from the contractors. I expect the costs to be beyond the \$10,000.00 limit, so full Commission approval may be needed for the project.
