## ORDINANCE NO. 1730

## ORDINANCE ANNEXING LAND FROM THE TOWN OF KAUKAUNA TO THE CITY OF KAUKAUNA FOR EUGENE BIESE

WHEREAS, a Petition for Direct Annexation signed by all owners of land within such territory, has been filed with the Clerk/Treasurer of the City of Kaukauna together with a scale map and a legal description of the property to be annexed showing the boundaries of such territory and the relation of the territory to the municipality to which annexation is requested, and

WHEREAS, notice of the proposed annexation was served upon the State of Wisconsin Department of Administration (Petition File Number 13841) and said Department determined that the proposed annexation is not against the public interest, and

WHEREAS, there has been due compliance with all requirements of Section 66.0217 of the Wisconsin State Statutes, and

WHEREAS, the property is being annexed for purposes of providing municipal services; and

WHEREAS, the matter was acted upon by the City Plan Commission which recommended annexation of the property;

NOW, THEREFORE, the Common Council of the City of Kaukauna do ordain as follows:

That the particular property hereinafter described pursuant to the Petition filed with the Clerk/Treasurer of the City of Kaukauna be, and the same is, hereby annexed to the City of Kaukauna, and the same is hereby detached, by operation of law, from the Town of Kaukauna, Outagamie County, Wisconsin. That the territory so annexed is known and described as follows:

All of Lot 1 of Certified Survey Map 7070, Outagamie County, Wisconsin, as part of the NW 1/4 of the NE 1/4 Section 18, Township 21 North, Range 19 East; and

Commencing at the North ¼ corner of said Section 18, T21N, R19E, thence S89. 55'25" East, 69.63 feet along the North line of the Northwest ¼ of the Northeast ¼ of said Section 18 to the point of beginning; thence continuing S89 55'26" East, 65.82 feet along said line; thence S39 37'25" East, 71.50 feet; thence N39 33' 34" East, 71.28 feet; thence S89 55' 25" East, 91.00 feet to the point of beginning.

Said parcel contains 2.19 acres, more or less.

FURTHER, BE IT RESOLVED by the Common Council of the City of Kaukauna that the City of Kaukauna shall pay and the Clerk/Treasurer is directed to pay to the Treasurer of the Town of Kaukauna, beginning with property taxes for the year 2016 and continuing through the year 2020, an equal amount to the property taxes that the town levied on such annexed territory, as shown by the tax roll under Section 70.65 Wisconsin Statutes for the year 2015.

This ordinance shall be in full force and effect from and after its adoption.
