ORDINANCE NO. 1732

ORDINANCE ANNEXING LAND FROM THE TOWN OF BUCHANAN TO THE CITY OF KAUKAUNA FOR GREG LAUER

WHEREAS, a Petition for Direct Annexation signed by all owners of land within such territory, has been filed with the Clerk/Treasurer of the City of Kaukauna together with a scale map and a legal description of the property to be annexed showing the boundaries of such territory and the relation of the territory to the municipality to which annexation is requested, and

WHEREAS, notice of the proposed annexation was served upon the State of Wisconsin Department of Administration (Petition File Number 13930) and said Department determined that the proposed annexation is not against the public interest, and

WHEREAS, there has been due compliance with all requirements of Section 66.0217 of the Wisconsin State Statutes, and

WHEREAS, the property is being annexed for purposes of providing municipal services; and

WHEREAS, the matter was acted upon by the City Plan Commission which recommended annexation of the property;

NOW, THEREFORE, the Common Council of the City of Kaukauna do ordain as follows:

That the particular property hereinafter described pursuant to the Petition filed with the Clerk/Treasurer of the City of Kaukauna be, and the same is, hereby annexed to the City of Kaukauna, and the same is hereby detached, by operation of law, from the Town of Buchanan, Outagamie County, Wisconsin. That the territory so annexed is known and described as follows:

Part of Lot 1 of Certified Survey Map No. 3921, and part of Government Lots 5, 6, and 7, Section 21, Township 21 North, Range 18 East, Town of Buchanan, Outagamie County, Wisconsin, more fully described as follows:

Commencing at the southwest corner of Section 30, Township 21 North, Range 19 East; Thence North 01 Degrees 04 minutes 32 Seconds East, along the East Line of Government Lot 1 of said Section 21, a distance of 950.77 Feet; Thence South 83 Degrees 20 Minutes 44 Seconds West, a distance of 1659.18 Feet to the point of beginning; Thence South 00 Degrees 23 Minutes 49 Seconds East, a distance of 107.38 Feet; Thence South 84 Degrees 10 Minutes 36 Seconds West, a distance of
