Grease Trap Inspections Summary Report

November 30, 2016

Sites Requiring Grease Trap Installation

Both Journeys Bar and Hillstreet Bar and Grill installed their grease traps in November. They were the last two businesses that were required to install traps under the guidelines of the FOG Control Program.

Summary of Site Visits & Correspondence:

Journeys Bar: The grease trap at Journeys Bar was installed on November 4, 2016. They will be assigned an initial cleaning schedule of 6 months.

Hillstreet Bar and Grill: The grease trap at Hillstreet Bar and Grill was installed on November 16, 2016. Mary Hoffman asked about the criteria for businesses that needed to install a grease trap and indicated that there were others bars that served food that were not in the program. I invited her to the December Commission meeting to discuss the criteria with the commission and she said she would be there.

Holy Cross Church: On November 23, 2016 we visited Holy Cross Church to check on their late submittal of their cleaning documents. The office had closed early that day for the upcoming holiday and we had to return on the 28th to talk with their maintenance man. The trap had been cleaned in September and he had forgotten to send over the document.

St Mary's Church: On November 23, 2016 we met with the business manager at St Mary's Church about the late submittal of the cleaning documentation. He said he would talk to his maintenance man and get right back to us. To date, we have not heard back.

Jimmy John's: On November 28, 2016, we met with Melissa at the newly opened Jimmy John's. They took over the site that was formerly occupied by Jack's Burger Shack. She cleans their trap weekly as part of their routine maintenance schedule and promised to send us a monthly summary.

Summary of Site Visits and Correspondence:

Little Caesars: On November 28, 2016, we stopped at Little Caesars and spoke to the manager about their grease trap cleaning schedule. She was unaware that they were past due and said she would talk to her manager as to when the trap was last cleaned. To date, we have not heard back from her.

Kimberly Assisted Living: On November 29, 2016, we stopped by Kimberly Assisted Living to check on their trap cleaning. We talked to Jay, their maintenance supervisor, who indicated that Flush had extended their cleanings out to one year. I informed him that we were unaware of this arrangement. We did check the condition of the trap and found it to be full of thick grease and in need of cleaning. We will have Flush stop out and check the trap condition and notify the owner of their findings.

Marcos Pizza: We are still awaiting the trap cleaning information promised by Jackie, at Marcos Pizza.

Summary of Correspondence and Site Visits

Dickey's Barbeque Pit: In early November, Dickey's Barbeque Pit shut down.

Pizza Ranch: On November 1, 2016, while performing routine manhole inspections, the lateral from Pizza Ranch was observed to be almost completely full of grease. We contacted the owner and told them to clean the line immediately. We also moved their trap cleanings schedule to monthly. On November 29, 2016 Speedy Clean cleaned the lateral and found numerous pockets of thick grease throughout. We will add this site to our periodic watch list.

Uno's, Stoneyard, Red Robin, Thai Sushi and Novo Grande. On November 8, 2016, the grease traps or discharge piping for all of the above locations were checked and found to be in need of cleaning within the next 30 days. Most are scheduled for cleaning in December and we may require the others to move up their schedule, if our December inspections show an immediate need for cleaning.

China Garden: On November 8, 2016, we checked the manhole downstream of China Garden and did not find any significant sign of a grease buildup on the sidewalls of the flow channel.

Artistic Cakes: On November 29, 2016, we stopped in at Artistic Cakes to discuss their past due cleaning. The manager indicated that the work had been done in house on November 15th, and she had forgotten to send over a cleaning slip.
