

# **Village of Kimberly Grease Trap Inspections Summary Report February 28, 2017**

## **Summary of Site Visits and Correspondence:**

**Hitters Bar:** Unless we personally stop in and speak to the bar owners, Hitters Bar does not submit any documentation related to their grease trap cleanings. They have again ignored our reminder letter and will require a personal visit. We have requested that the Village of Kimberly take advantage of the HOVMSD offer of televising assistance to help determine if Hitters Bar is even cleaning their grease trap and/or discharging grease to the sanitary sewer.

**Subway:** On January 27, 2017, we visited the Subway store and were told that they only clean their grease trap when the sewer lines start to plug. The restaurant owner indicated that he would have the trap cleaned immediately but has not forwarded the documentation. We will again contact him to verify that the trap was cleaned.
