**Grease Trap Inspections Summary Report**  
**June 30, 2017**

**Summary of Site Visits & Correspondence:**

**Benchwarmers:** We finally made contact with the owner of Benchwarmers and he says that he was unaware of the document submittal requirements of the Ordinance. We confirmed with him that he had cleaned the trap and sent over the contact information so he will be able to let us know after all future cleanings.

**Subway:** On June 29, 2017, we visited the Subway Restaurant and talked to the owner about their tardiness in cleaning the grease trap. He indicated that he was shutting down the store in July, moving to another facility and does not plan on cleaning the trap.

**Hilltop Bakery:** On June 25, 2017, we talked to the owner of Hilltop Bakery and she asked that her cleanings be moved to 6 months. Early in the FOG Control Program they cleaned their trap more frequently because of issues with solids (flour) in the trap, more so than grease. They have apparently resolved that issue and a check with their cleaning contractor confirmed that a 6 month schedule would be sufficient.

**Orange Chicken Hut:** The site that was to be occupied by Orange Chicken Hut will soon be occupied by Cozy Corner. We have sent an introduction letter to the new owners and should perform our initial site inspection/program introduction, in July.

# **Village of Combined Locks Grease Trap Inspections Summary Report June 30, 2017**

## **Summary of Site Visits and Correspondence**

**Christ the King Church:** On June 29, 2017, we visited Christ the King Church to get a status on their overdue grease trap cleaning. Rebman Plumbing does their trap cleanings and had not cleaned the trap yet. We contacted Rebman Plumbing and requested that they have the trap cleaned within the next 14 days.

**Rico's Family Restaurant:** On June 29, 2017, we contacted Rico's trap cleaning contractor to determine if they had cleaned the trap and forgotten to submit the paperwork. Kuettels Septic indicated that they had cleaned the trap on June 15<sup>th</sup> but they have noted that the trap has been almost devoid of any grease the last few cleanings. This would be unusual for a family style restaurant, so we contacted Ryan Swick at the Village of Combined Locks and asked to have his staff take a look at the first downstream manhole from the restaurant. Ryan sent over a photo of the manhole, which was very clean and another of a televising still photo of Rico's lateral. The lateral appeared to be half filled with grease.

Based upon what we know, it appears that the grease discharged from the restaurant is bypassing the grease trap. How this is happening and what action should be taken would be a good discussion item at the July HOVMSD Commission meeting.

# Darboy Joint Sanitary District #1 Grease Trap Inspections Summary Report June 31, 2017

## Summary of Correspondence and Site Visits

**Island Sushi:** The grease trap at Island Sushi was installed on June 27, 2017. They will initially be assigned a six month cleaning schedule.

**Little Chicago, China Garden, Thai Sushi, Stoneyard, Unos, Red Robin and Novo Grande:** On June 13, 2017, the grease traps or downstream manholes for all of the above locations were checked. All the traps or manholes were in good condition.

**Mohnen's Family Restaurant:** On June 13, 2017 we checked the downstream manhole from Mohnen's Family Restaurant and found the downstream pipe to be partially blocked by, what appeared to be a chunk of grease and an accumulation of rags. We broke up the blockage and no further sign of grease in the manhole or piping were noted.

**Pizza Ranch and Mac's:** On June 28, 2017, we checked the manhole downstream of Pizza Ranch and Mac's and found that the grease accumulation on the sidewalls and bench had not gotten worse since the May inspection.
