## **Summary of Correspondence and Site Visits**

**Little Chicago, China Garden, Thai Sushi, Stoneyard, Unos, Red Robin Pizza Ranch, Kimberly High School and Novo Grande:** On August 17, 2017, the grease traps or downstream manholes for all of the above locations were checked. All the traps or manholes were in good condition.

**A&W:** On August 17, 2017 we checked the trap at the A&W Restaurant and found it to be clean. We have been trying for over a month to schedule a meeting with a manger there to find out why the documentation is not submitted after cleaning.

**Panda Express:** On August 17, 2017 we checked the grease trap t Panda Express and found it to be in very good condition. We have not established a cleaning frequency for them because they appear to produce very little grease.

## **Summary of Site Visits and Correspondence:**

**Kimberly Assisted Living:** In August, both grease traps at the Kimberly Assisted Living facilities were cleaned. We contacted the cleaning contractor about the facility manager's insistence on longer spans between cleaning and the contractor agreed that the current cleaning schedule could be changed. We have made those changes per the cleaning contractor's recommendations.

**Mr. Taco:** On August 30, 2017, we stopped at the Mr. Taco site and found that they are not yet open. We have sent them the introduction package to the program and hope to meet with them prior to opening.

# Village of Little Chute Grease Trap Inspections Summary Report August 31, 2017

## Summary of Site Visits & Correspondence

**Main Event Steakhouse & Tom's Drive In:** On August 4, 2017, Marty Jansen from the Village called to say that they had found grease in both the Main Event and Tom's laterals and were requiring that they be cleaned. We will monitor those businesses and review their contractor documentation to determine if the problem is failure to clean on schedule or a need to increase their cleaning frequency.

**Tom's Drive In:** On August 30, 2017, we met with a manager from Tom's Drive In to discuss their late submittal of their cleaning documentation and the issues noted by the Village. The manager was under the impression that they were on a three month schedule. We informed him that the schedule had changed to two months several years back. They have normally kept their schedule although their recent departure from it may explain the issues with grease in their lateral.
