

Darboy Joint Sanitary District #1 Grease Trap Inspections Summary Report October 31, 2017

Summary of Correspondence and Site Visits

Little Chicago, China Garden, Thai Sushi, Stoneyard, Unos, Red Robin and Walmart: On October 2, 2017, the grease traps or downstream manholes for all of the above locations were checked. All the traps or manholes were in good condition.

Novo Grande: On October 2, 2017, the exterior trap at the Novo Grande Building (El Azteca) was checked and found to be thick with grease. The management from El Azteca will be personally directed to clean the exterior grease trap while representatives from the Darboy Sanitary District are on-site to perform their cross connection inspections. A reminder letter will also be sent out to Pfefferle Management.

Mac's/Pizza Ranch: On October 2, 2017 we checked the downstream manhole from Mac's and Pizza Ranch. The Mac's lateral had a significant grease build up, to the point that it was beginning to back up the laterals from Biolife and Pizza Ranch. On October 25, 2017, representatives from Darboy Sanitary District flushed out the manhole and removed the grease buildup. Mac's was sent a letter the next day changing their grease trap cleanings from three months to two months.

Ban Vinai (Formerly Four Seasons Catering): On October 2, 2017, we checked the trap at Ban Vinai and found it to be plugged with grease. The facility appears to maintain odd hours and is open only for special events. They have ignored all efforts to contact them in regards to their grease trap cleaning or cross connection testing. A potential utility disconnect will be discussed at the next Darboy Joint Sanitary District meeting, as the first effort to get them back into compliance.

Grease Trap Inspections Summary Report

October 31, 2017

Summary of Site Visits & Correspondence:

2nd Street Grease: On October 4, 2017, we talked to John Neumeier about the discovery of grease in the sanitary sewer near the restaurants on 2nd Street. We encouraged the City to contact HOVMSD and arrange to have that section of sewer televised to determine which lateral(s) were contributing the grease.

Plan B: On October 24, 2017, we stopped by Plan-B to observe their food service operation. They offer a menu that is comparable to the other bars, who have been required to install grease traps. They do lack a food prep area and the facilities for cleaning and sanitation that most bars serving food have. The cooking is done in a self-contained fryer/grill and the food is served on disposable plates. Whether they will be required to install a grease trap will be discussed at the next Commission meeting.

St Mary's Church: On October 31, 2017, we stopped in at St Mary's to discuss their overdue grease trap cleaning. The maintenance man checked the cleaning chart and confirmed that it was overdue for cleaning. This will be completed and the paperwork submitted within a week.
