Summary of Correspondence and Site Visits

Ban Vanai (Bella Thai), Novo Grande, Thai Sushi, Stoneyard and Red Robin: On January 10, 2018, the grease traps or downstream manholes for all of the above locations were checked. All the traps or manholes were in good condition.

Noodles & Company: On January 17, 2018, we met with the new manager at Noodles & Company to explain the FOG Program and discuss their failure to submit the documentation of their cleanings. He indicated that he was unaware of the requirements and had Corporate forward over the last cleaning slip.

Chipotle: On January 18, 2018, we met with the new manager at Chipotle and had a similar conversation as the one the previous day at Noodles. We were contacted by Arcade Pumping, who promised to send over the past due documentation and keep us on their list for any future submittals. The documents had not arrived prior to preparation of this report.

Mac's Macaroni and Cheese Shop: On January 26, 2018, we met with the manager at Mac's Macaroni and Cheese Shop to discuss the FOG Porgram. He indicated that he would also have to talk to corporate. We did remind him that his facility has been responsible for grease in the municipal sewer and could be subject to cleaning costs as well as non-compliance penalties. He said he would inform Corporate. To date, nothing has been received.

Stoneyard: On January 26, 2018, we met with the new manager of Stoneyard and explained the requirements of the FOG Program. She indicated that she had to get the paperwork from the restaurant owners. To date, nothing has been received.
