

Darboy Joint Sanitary District #1 Grease Trap Inspections Summary Report July 31, 2018

Summary of Correspondence and Site Visits

Speedy Clean: We contacted Speedy Clean about several of their clients who were late with their grease trap cleanings and were informed that they had several workers off due to injuries and had fallen behind on servicing their customers with scheduled cleanings. They indicated that they hoped to be caught up by the end of August.

Uno's, Thai Sushi, Red Robin, Walmart, Stoneyard, Little Chicago and Novo Grande: On July 12, 2018, the grease traps or downstream manholes for all of the above named locations were checked. All the traps or manholes were in good condition.

Ban Vinai: On July 12, 2018, we checked the trap at Ban Vinai and found the trap to still be in need of immediate cleaning. Efforts to contact the restaurant owner to resolve the issue have so far been unsuccessful. The restaurant does not hold normal business hours, complicating our efforts to meet anyone on-site to discuss the problem.

Pizza Ranch/Mac's: On July 12, 2018 we performed our monthly check at the downstream manhole from Pizza Ranch/Mac's and found there was no significant increase in the accumulation of grease in the manhole.
