## **Overview by Community**

**Darboy Sanitary District**: We continue to struggle to get the larger chain establishments to submit their documentation in a timely manner. Most are having their traps cleaned on a set schedule but, require a site visit to get the paperwork submitted.

A total of 1 reminder letter is required and 3 site visits will be conducted.

**Village of Combined Locks**: There were no significant issues, related to the FOG Control Program, in September.

No reminder letters are required and no site visits needs to be conducted.

**Village of Kimberly**: There were no significant issues, related to the FOG Control Program, within the Village, in September.

#### **Summary of Correspondence and Site Visits**

Uno's, Red Robin, Stoneyard, Little Chicago, China Garden, Mac's/Pizza Ranch, Thai Sushi, Ban Vinai, Walmart and Novo Grande: On September 24, 2019, the grease traps or downstream manholes for all of the above named locations were checked. All the traps or manholes were in good condition.
