Dear Community Facilities Committee,

The Village of Little Chute has reviewed the SSA application from Outagamie County Solid Waste and the Regional Plan Commission’s memorandum on the application. Based upon our review, please accept this letter as an official response to the proposed amendment.

We note per the staff memo that a “full cost-effectiveness analysis was not completed”. Given the gravity of the amendment, the expense to treat leachate, and the indefinite timeframe and amount of leachate that the NWLF will discharge, we urge the committee or applicant conduct an independent, third party study to analyze the efficacy, reasonableness, and actual cost benefit of the application. The magnitude of this decision requires a formal engineering study and complete cost benefit analysis of viable alternatives. This course of action would set a proper example of governance and establish a precedent for future amendments.

If the committee does not direct a complete analysis, we then urge the committee to alter the SSA and release the entirety of the landfill property to the City of Appleton. Dividing the Outagamie County Solid Waste property between two SSA’s will lead to issues in the future regarding where and how much leachate is being transported to separate facilities (note Outagamie County’s backup or emergency plan for the NWLF). As the Outagamie County Solid Waste Department has experienced, monitoring the amount and the timing of the release of leachate leaving an active landfill has proved sporadic and problematic. Splitting a single site into different SSA’s will most likely make matters worse, sets a poor example of planning, and creates a precedent that is untenable. One relevant example is the fact that Little Chute currently provides water service via a 12 inch main to the proposed area to be amended.

The Village of Little Chute appreciates the opportunity to be a part of this discussion. A regional landfill that benefits more than 700,000 Northeast Wisconsin residents is a benefit and responsibility that must thoroughly vet alternatives. We look forward to working through this matter with all parties involved.

Outagamie County has submitted an application to amend the 2030 Appleton Sewer Service Area (SSA) and the 2030 Heart of the Valley SSA. This amendment request proposes to amend the SSA boundaries along the borders of these two separate SSAs to accommodate the development and expansion of the County's landfill facility. This proposed amendment does not fit nicely into East Central's SSA Amendment Policies; however East Central is proceeding with guidance from both Policies I, C (Unique Facility) and I, F (Mapping Error). The use of these amendment policies provide communities the flexibility to proceed with infrastructure projects in a timely fashion. This amendment, if approved, will allow Outagamie County to install planned sewer infrastructure while working with East Central, the City of Appleton, Village of Little Chute, and the Heart of the Valley Metropolitan Sewerage District (HOVMSD) on the 2040 Fox Cities Sewer Service Area plan update.

The proposed SSA amendment request is due to development of the Northwest Landfill (NWL) cell on a faster pace than East Central's timeline for the Fox Cities SSA Plan Update in 2020. The Outagamie County Landfill is a 450 acre property located in the Village of Little Chute consisting of three landfills. The closed East Landfill is located to the south of the active Northeast Landfill. The 450 acre property is split by existing American Transmission Company high voltage transmission lines. The closed West Landfill and the proposed NWLF are located to the west of the transmission lines (see Foth Map – Figure 1 provided by the County).

Leachate generated from the closed East Landfill and the active Northeast Landfill flow through the Village of Little Chute's sanitary system and is treated by the Heart of the Valley Waste Water Treatment Plant (WWTP). Leachate generated from the closed West Landfill flows through an existing lateral that connects to the City of Appleton's sanitary system and is treated by the Appleton WWTP. This existing lateral and the Appleton WWTP have been serving the West Landfill since the 1980s; however this is not mapped correctly on either the Appleton SSA plan or the Heart of the Valley (HOV) SSA Plan. Currently the 2030 HOV SSA shows the entire County Landfill in HOV's SSA boundary. Additionally, Cedar Creek (located at 3220 E Northland Ave, Appleton) is serviced by this sewer lateral and is treated by the Appleton WWTP, but is mapped as part of the HOV SSA.

The County provided letters to the HOV WWTP and Appleton WWTP as part of the NWLF Feasibility Report discussing expected leachate flows and treatment needs. The Appleton WWTP confirmed that the plant has capacity and is willing to accept the projected leachate flows (copy of letter is within the County's SSA Amendment Request materials). The HOVMSD provided an email that the HOV WWTP does not have capacity and would not be willing to accept the

leachate. Discussion with HOVMSD and the County concluded that the HOV WWTP can accept and treat leachate only if the County provides on-site pre-treatment of the NWLF's leachate.

As proposed, the new NWLF cell would be serviced through the extension of existing gravity sewer lines as shown on the attached map.

Although a full cost-effectiveness analysis was not completed, a preliminary estimate of installing an on-site pre-treatment system under the current SSA configuration would be in excess of five million dollars. In addition, it is estimated that extending a sanitary lateral from the NWLF to the Village of Little Chute's existing sanitary sewer location would add an additional one million dollars. These two additional infrastructure requirements and their high costs would certainly make the planned sewer extension the more cost-effective option.

The proposed SSA boundary amendment removes a total of 271.2 SSA & Planning Area acres from the HOV SSA and adds a total of 294.8 SSA & Planning Area acres to the Appleton SSA. The additional 23.6 acres was added as part of the amendment to address property along French Road. This area was not within either SSA or Planning Areas. Until now it was undetermined who (City of Appleton or Village of Little Chute) could cost effectively service this area.

Current Boundaries

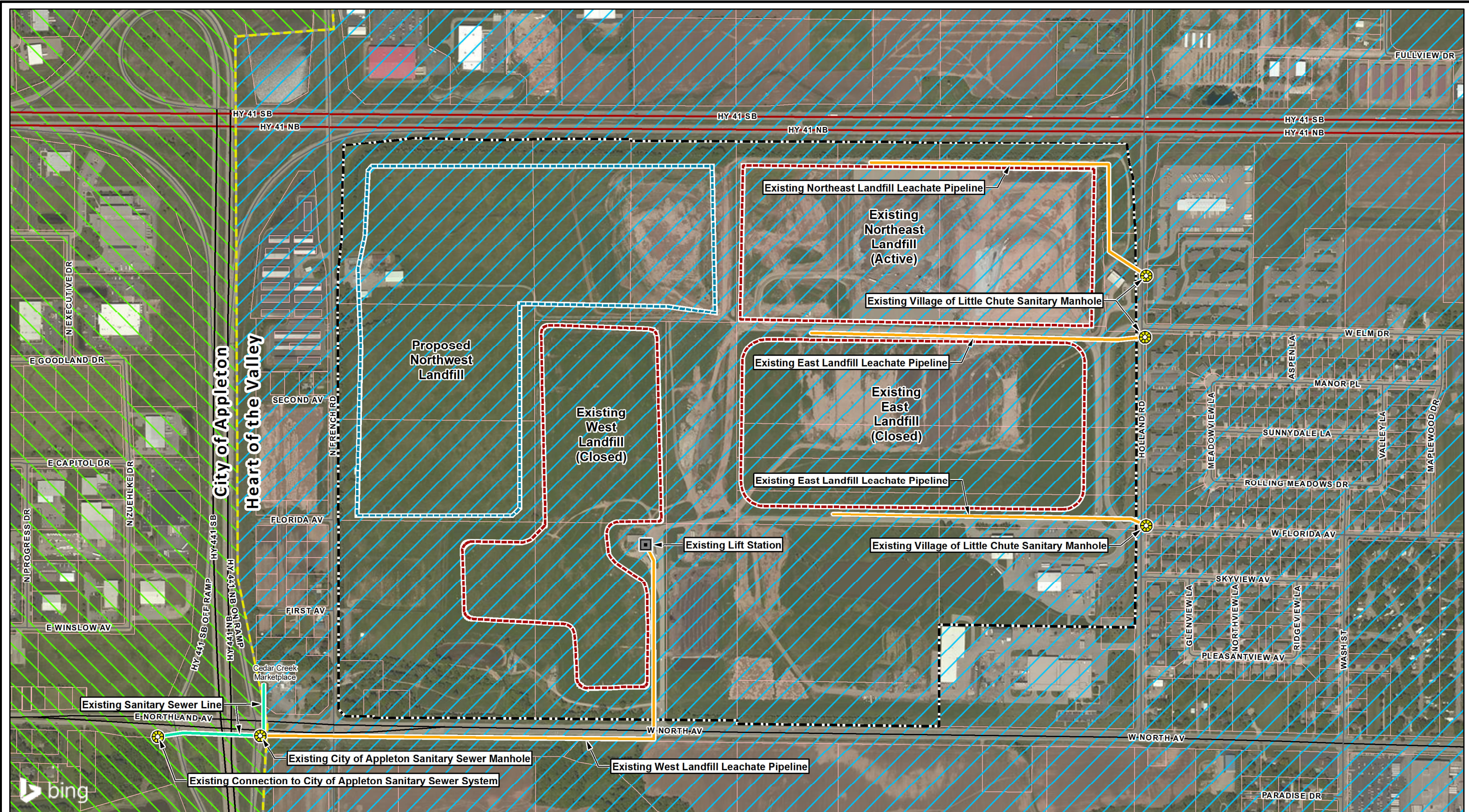

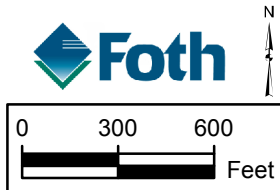

Dear Mr. Van Straten

The City of Appleton Wastewater Treatment Plant (AWWTP) has reviewed the Outagamie County Northwest Landfill Wastewater Acceptance request letter and attachments dated June 27, 2018. It is our understanding that for the OCRWS to proceed with the proposed Northwest Landfill siting process that the Wisconsin Department of Natural Resources per Administrative Code Chapter NR 512 requires identification of treatment options. This letter serves to acknowledge our understanding that the AWWTP will receive leachate from the proposed Northwest Landfill immediately following final construction.

Historical leachate discharge rates and characteristic data provided by OCRWS as part of this discharge request were modeled to determine the ability of the AWWTP to effectively assimilate and treat conventional pollutant loads associated with the future Northwest Landfill. The projected flows from the future proposed Northwest Landfill do not appear to impose hydraulic limitations based on AWWTP hydraulic design capacities and annual daily average flow data.

Currently the OCRWS discharges leachate to the AWWTP from the landfill's West Pumping Station under the authorization of wastewater discharge permit number 17 – 10. The current landfill Industrial User (IU) permit is in effect until May 31, 2020. The OCRWS IU permit (17 – 10) will be amended to include an additional designated outfall for the proposed Northwest Landfill prior to final construction. The current OCRWS IU permit is scheduled for triennial renewal on June 1, 2020 (for period 2020 to 2023).

Presently the AWWTP is subject to phosphorus and total suspended solids limits under the current Wisconsin Pollutant Discharge Elimination System (WPDES) permit and the AWWTP has a billing rate based on Total Suspended Solids (TSS) and Biochemical Oxygen Demand (BOD). This billing structure may change as AWWTP adapts to current and future conventional pollutant limits, in this case ammonia. These limits are the result of new State of Wisconsin's Total Maximum Daily Load (TMDL) and Water Quality Based Effluent Limits (WQBELs) for the Lower Fox River (LFR). Discussions at the Federal and State regulatory agency level have been ongoing regarding more stringent ammonia requirements which would impact future reissued WPDES permits.


There is an ongoing evaluation of viable treatment upgrades at the AWWTP that would be capable of effectively and consistently reducing nutrient. This evaluation process requires a review of waste characteristic data and related information from all permitted Industrial Users (IUs) as part of Appleton's Pretreatment Program. It is AWWTP's goal to find the most efficient and cost effective means of complying with future more stringent ammonia limits which will not only serve the best interests of City of Appleton rate payers but all customers including the OCRSW.

The aforementioned regulatory changes and increased costs to treat to more stringent standards requires the City of Appleton to conduct a sewer user rate study within the next two years. The current City of Appleton quantity/quality discharge rates for permitted IUs is based on flow (\$1.73 per 1,000 gallons), BOD (\$35.48 per 100 pounds), and TSS (\$11.26 per 100 pounds). The future rate structure for permitted IUs will incorporate fees for total phosphorus and ammonia nitrogen. The corresponding fee structure will be determined by the rate study.

In conclusion, this letter serves to acknowledge our understanding that the AWWTP will receive leachate from the proposed Northwest Landfill and provide effective treatment to maintain compliance with WPDES permit limits. It is expected that the OCRSW would maintain active dialog with the Utilities Department leading up to and during the construction of the proposed Northwest Landfill. This includes providing updated leachate characteristic and discharge flow data representative of the proposed Northwest Landfill.

As it is, the delivery of the leachate to the Little Chute system and ultimately the HOVMSD is problematic and is by definition slugging the treatment plant with ammonia. The status quo method of leachate delivery – pumping as and whenever necessary - is not going to be acceptable to HOVMSD in the future. The landfill's footprint is ever expanding and along with that, is its effect on the treatment process at the treatment facility. We are currently gathering data on strengths and flows to get a handle on the total load from the landfill.

I and the Commission are open to ideas and potential solutions moving forward. Your consultant, Foth, brings up a desire to identify a flow or mass target value that HOVMSD can process without permit compliance issues. In the wastewater world that describes a process and set of calculations called a "Local Limit" and its results would be imposed on all industrial permit holders and be included in the Sewer Use Ordinance. The setting of a local limit is a complicated and time consuming task that is generally done with the assistance of an outside technical consultant. We do not have a consultant agreement or a consultant on retainer at this time .

Before moving to the step of enacting a local limit, I'd like to discuss the landfills' loading and delivery of leachate to HOVMSD. It is possible that with some engineering changes and implementation of enhanced pumping controls, a local limit may not be necessary. There are many moving parts in this discussion and that is the primary reason for wanting to sit down and meet with you to discuss the issues and hopefully we come away with a better understanding of each other's needs and limitations. In the end, a local limit may end up being the answer for this issue. Let's exhaust all other options and see what we can collectively come up first.

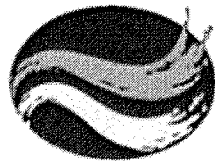
