## Brian/Greg:

The following responses are intended to build upon discussion points and our conversation when you were here for the WWTF tour on 1/29/20. As we informed you during your site visit, the District is currently analyzing the historical loadings and the unit processes used in the HOVMSD treatment process. This process begins master planning efforts to identify both near- and long-term efforts that may be required of the District in meeting its NPDES permit obligations. Part of the planning process may include the study and implementation of local limits for permitted dischargers to HOVMSD. The District has requested a proposal from its consultant to provide technical assistance in determining local limits and any action taken on said proposal is at the sole discretion of the HOVMSD Commission.

1. If Outagamie County were to transmit the NW landfill leachate to HOV, would Outagamie immediately need to pretreat, or would there be a lag before pretreatment would be required, similar to Appleton's three-year estimate for pretreatment?

Given the increase in organic loadings the District has been seeing, there is insufficient organic capacity remaining to take on the load from the proposed NW landfill cell without pretreatment of the raw leachate prior to discharge to the sanitary system. With the current organic loadings, and with the District approaching its organic design limits, pretreatment should be planned for upon startup of the cell if discharged to HOVMSD. The District would suggest that any technology evaluated for leachate pretreatment include provision of capacity to include pretreatment of the leachate from the current active NE landfill cell.

2. If Outagamie County were to transmit the NW Landfill to Appleton, would there ever be a need for pretreatment of the NE and East landfills' leachate by HOV, given the declining ammonia levels of the NE and East landfills' leachate?

The District cannot guarantee there will never be pretreatment required of the NE or East cells currently being discharged to the Little Chute sanitary system and ultimately to HOVMSD. It is impossible to know what pollutants or contaminants of concern may arise in the future and require actions by the District. The District reserves the right to modify its Sewer Use Ordinance and local limits as necessary to comply with its NPDES permit and with any future Wisconsin DNR requirements. As a significant industrial user and permitted discharger in the HOVMSD pretreatment program, Outagamie county (landfill) has been and will be subject to all current and future limits and/or terms and conditions found within its wastewater discharge permit.

3. Is HOV, under any circumstances, willing to accept the NW landfill leachate or would they prefer that we go to Appleton for the NW leachate?

The District would not accept raw leachate due to its organic strength (ammonia and BOD), however, the treatment facility is not hydraulically (gallons of flow) challenged and can process the additional flow from the NW cell if it receives pretreatment first and is then discharged to the sanitary sewer.

HOVMSD has no preference in where the leachate is discharged.

4. If HOV is willing to take our combined leachate, if so, what exactly are the specifications and modifications necessary for an HOV concurrence letter to accept NW landfill leachate?

HOVMSD is unable to provide removal requirements or exact leachate specifications at this time.

Any letter of concurrence would be contingent upon pretreatment of the leachate to whatever present and future standards are contained within its pretreatment discharge permit.
