Overview by Community

Darboy Sanitary District: Little Chicago has re-opened with limited service hours and Island Sushi remains temporarily closed. A total of 5 reminder letters are required and 4 site visits will be conducted.

Village of Combined Locks: There were no significant issues, related to the FOG Control Program, in August. One reminder letter is required and no site visits will need to be conducted.
