# HOVMSD FOG Control Program Update

## September 2020

### **Overview by Community**

**Darboy Sanitary District**: We met with the managers of Island Sushi and Little Chicago and asked them to schedule cleanings. These were the last two restaurants that were past due on their cleanings pre-Covid and had only recently re-opened. Little Chicago has re-opened with limited service hours and may require an adjustment to their schedule going forward. A total of 3 reminder letters are required and 7 site visits will be conducted.

**Village of Combined Locks**: There were no significant issues, related to the FOG Control Program, in September. One reminder letter is required and no site visits will need to be conducted.

**Village of Kimberly**: Savor has closed for remodeling and is scheduled to re-open in October. Pho Papa was visited in September and asked to clean their grease trap immediately because the former owners had failed to do so. A total of 1 reminder letter is required and 2 site visits will be conducted.

**Village of Little Chute**: We could not get a response from the local or Corporate Taco Bell contacts and tracked down their cleaning contractor to determine if they were following their cleaning schedule. The contractor has been maintaining the grease trap and will email us after future cleanings. A total of 2 reminders letter are required and 4 site visits will be conducted.

**City of Kaukauna**: Pizza Hut continues to be an issue in regards to responding to our inquiries. We did talk to the local manager and told her they would be issued a Notice of Non-Compliance if they did not provide us with the requested cleaning documents. If they don't respond by October 15<sup>th</sup>, we will recommend they be issued the notice. A total of 3 reminder letters are required and 3 site visits will be conducted.

### Summary of Site Visits & Correspondence

**Pho Papa:** On September 29, 2020, we stopped by Pho Papa and talked to the manager about the FOG Control Program. We told her that the old owners were past due on their cleaning and the trap was most likely full of grease and in need of immediate cleaning. She said the owner would contact us to discuss.
