Overview by Community

Darboy Sanitary District: SALT has opened up in the former Little Chicago site. We inspected their grease trap prior to opening and they are now compliant. The store managers at Qdoba were less than helpful in supplying documentation of their trap cleanings. A call to the regional manager was necessary to bring them back into compliance. A total of 5 reminder letters are required and 3 site visits will be conducted.

Village of Combined Locks: There were no significant issues, related to the FOG Control Program, in May. One reminder letter is required and no site visits are necessary.

Village of Kimberly: iL Bar Coffeehouse and Bistro is currently working with a contractor to install a grease trap. The grease trap at Liberty Hall was personally inspected to verify that their significant downturn in business necessitated a review of their cleaning schedule. The trap was in good condition and will not require cleaning for some time. We will monitor the site over the summer. One reminder letter is required and 2 site visits will be conducted.

Village of Little Chute: Country Inn and Suites shut down their food service area for the past year. Their trap cleaning schedule has been adjusted accordingly. Five reminder letters are required and 1 site visit will be conducted.

City of Kaukauna: In response to the Notice of Non-Compliance, we finally heard back from management at The Mariner. They are operating on significantly reduced hours and we agreed to move them to an annual cleaning schedule. The former Quenchers has re-opened as Sticky Fingers Cafe and Catering. We will visit them in June to verify they have installed a grease trap. A total of 1 reminder letters is required and 5 site visits will be conducted.

Summary of Site Visits & Correspondence

Uno's, Red Robin, Stoneyard, SALT (formerly Little Chicago), China Garden, Mac's/Pizza Ranch, Thai Sushi, Ban Vinai, Walmart and Novo Grande: On or around May 14, 2021, the grease traps or downstream manholes for all of the abovenamed locations were checked. With the exception of Stoneyard, all of the grease traps or manholes were in good condition. The Stoneyard is currently closed and for sale and the trap would need to be cleaned prior to any resumption in operations.

Qdoba: On May 27, 2021, we met with the assistant manager of Qdoba about their chronic issues with failing to provide us documentation of their grease trap cleanings. She indicated that no other municipality requires documentation be submitted for grease trap cleanings and Sanimax does not supply copies of their site reports. We asked her for the name of a responsible party who could come and relate that to the Commission. We were given the name of a regional manager and, after one phone call, had the information forwarded to us from Sanimax the next day. The regional manager asked that we deal with him going forward to avoid any future misunderstandings.
