HOVMSD FOG Control Program Update

December 2021

Overview by Community

Darboy Sanitary District: While Qdoba continues to struggle to get their documents from Sanimax in a timely manner, management of the A&W has failed to keep their promise to clean their trap for two months running and is challenging the authority of HOVMSD to set guidelines in regards to cleaning schedules. The manger has been invited to the January Commission meeting at both Darboy and HOVMSD to explain. A total of 4 reminder letters are required and 3 site visits will be conducted.

Village of Combined Locks: There were no significant issues, related to the FOG Control Program, in December. No reminder letters are required and one site visits will need be conducted`.

Village of Kimberly: Il Bar Coffeehouse and Bistro is still on target for the installation of their grease trap by the end of January. They will be joined in their building by a new restaurant. Details of such are currently in the planning stages. No reminder letters are required and 1 site visit will be conducted.

Village of Little Chute: The owner of Hawks Nest suffered some medical issues, which kept him from self-cleaning his trap. He is back at work and will clean the trap in late December. Three reminder letters are required and 1 site visit will be conducted.

City of Kaukauna: There were no significant issues, related to the FOG Control Program, in December. A total of 3 reminder letters are required and 3 site visits will need to be conducted.

Summary of Site Visits & Correspondence

Uno's, Red Robin, Stoneyard, SALT, China Garden, Mac's/Pizza Ranch, Thai Sushi, Ban Vinai, Walmart and Novo Grande: On or around December 12, 2021, the grease traps or downstream manholes for all of the above-named locations were checked. With the exception of Stoneyard, all of the grease traps or manholes were in good condition. The Stoneyard is currently closed and for sale and the trap would need to be cleaned prior to any resumption in operations. In December, we also used a fire hose to clean the manhole downstream of Mac's Macaroni and Pizza Ranch to remove toilet paper and other solids from the flat bench. This is usually done once per year.

A&W: Over the course of the month, we spoke with the general manager of the A&W Store about his promise to have the grease interceptor cleaned in early December and the fact that it remains in immediate need of cleaning as of December 31, 2021. While promising to clean the interceptor, the manger disagrees with our authority to make him do so. Our next step is to invite him to both the Darboy Sanitary District and the HOVMSD January Commission meetings to present his case.

Qdoba: Over the course of the month, we have had several discussions with the restaurant manager at Qdoba about timely submittal of their cleaning documents. She disagrees that we should require real time submittals of their cleaning documents and her promises to provide us with a management contact to present our case to the contrary has not been fulfilled. She did call us on December 27th to say that the trap was cleaned around December 15th and she was still working on getting the information from Sanimax.

We also reached out to Sanimax to get a local contact in which we could discuss how to better coordinate data submittal. The message went to their corporate office in Canada and we have not received a response back.

Thai Sushi: On December 31, 2021, we checked the manhole at Thai Sushi and found it to be in good condition. They are past due in our database for a cleaning but, they have either recently cleaned the grease trap or are discharging less grease than normal. We will push out their due date to reflect the condition of their trap.
