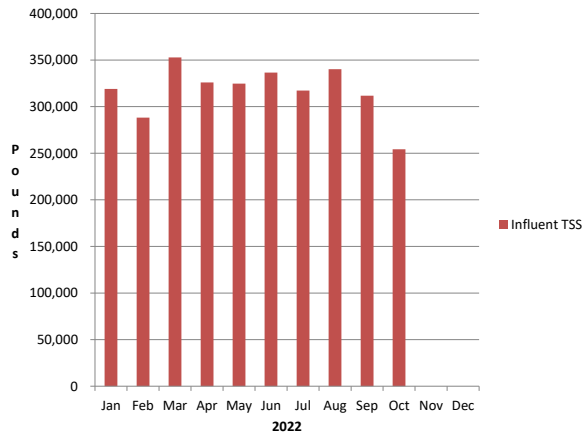

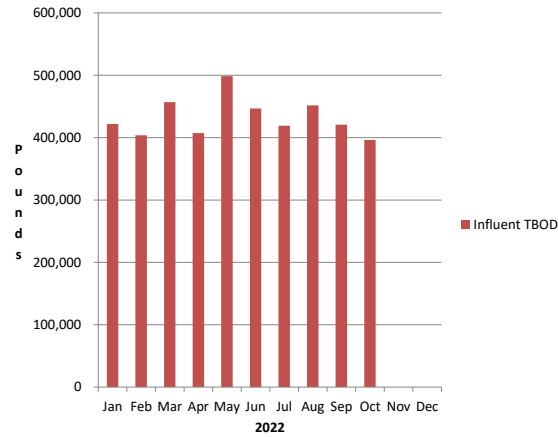

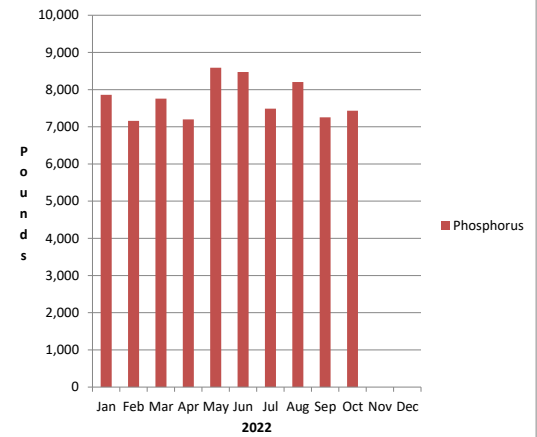
**Influent TSS Total Pounds/Mo.**



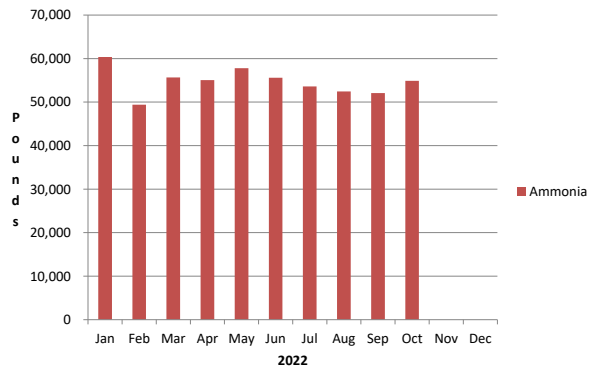
**Influent BOD Total Pounds / Mo.**



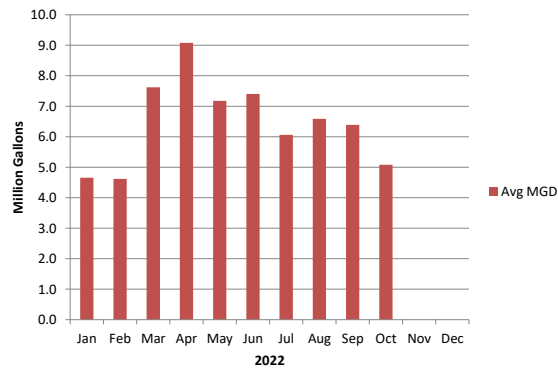
**Influent Phosphorus Total Pounds/Mo.**



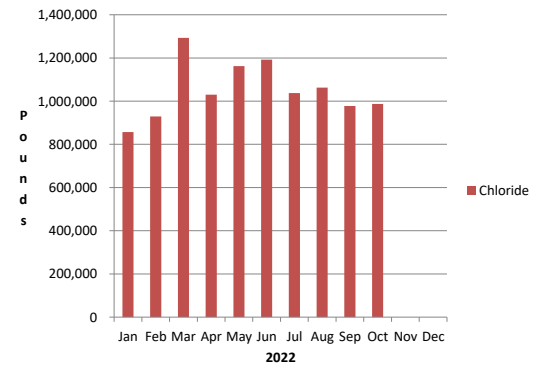
**Influent Ammonia Total Pounds/Mo.**

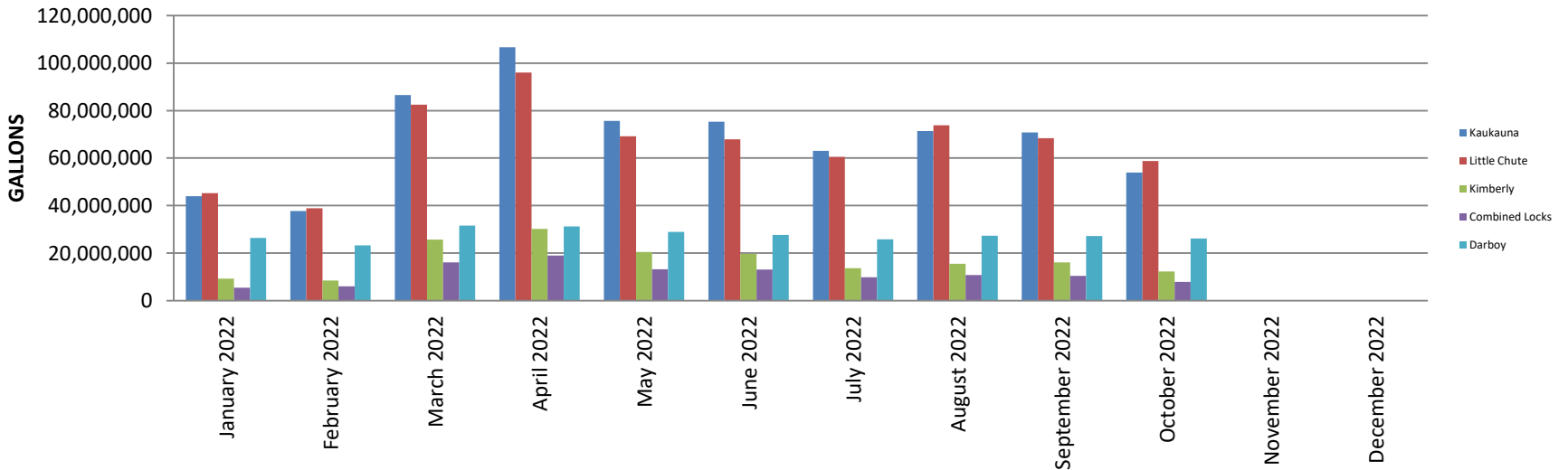
