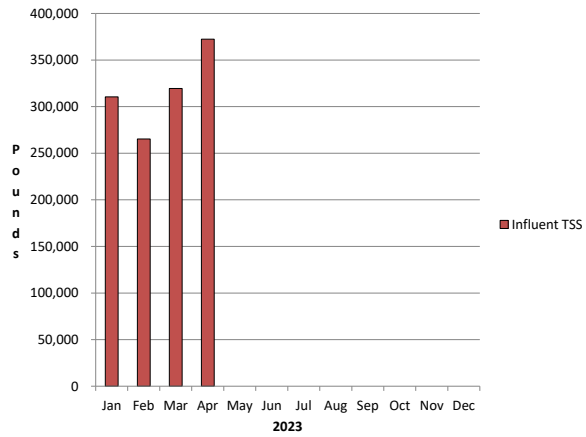

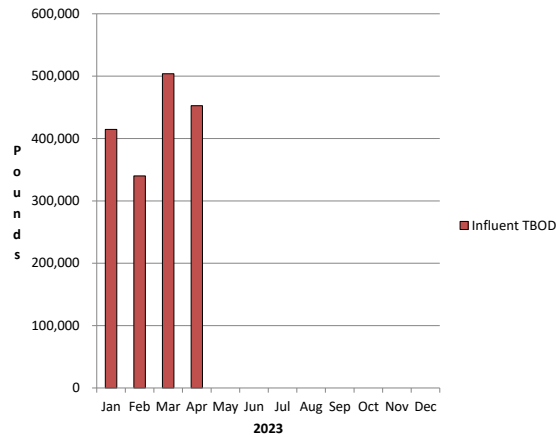

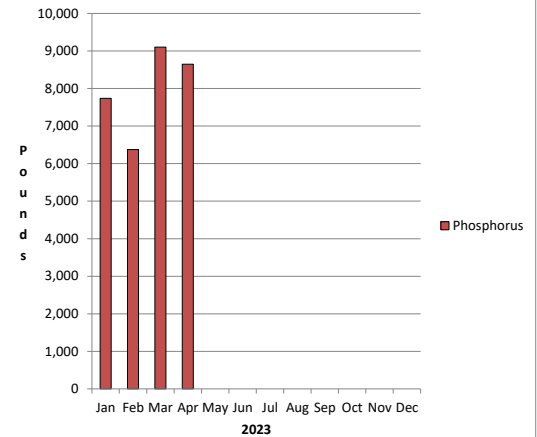
Influent TSS Total Pounds/Mo.



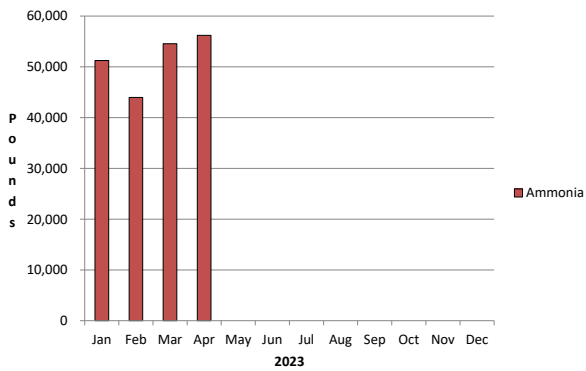
Influent BOD Total Pounds / Mo.



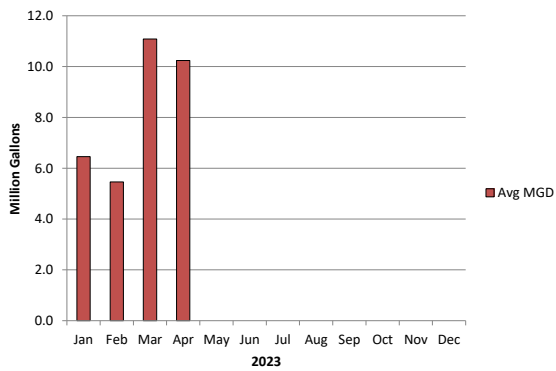
Influent Phosphorus Total Pounds/Mo.



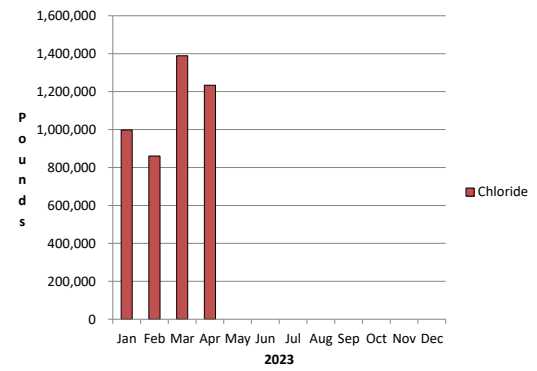
Influent Ammonia Total Pounds/Mo.

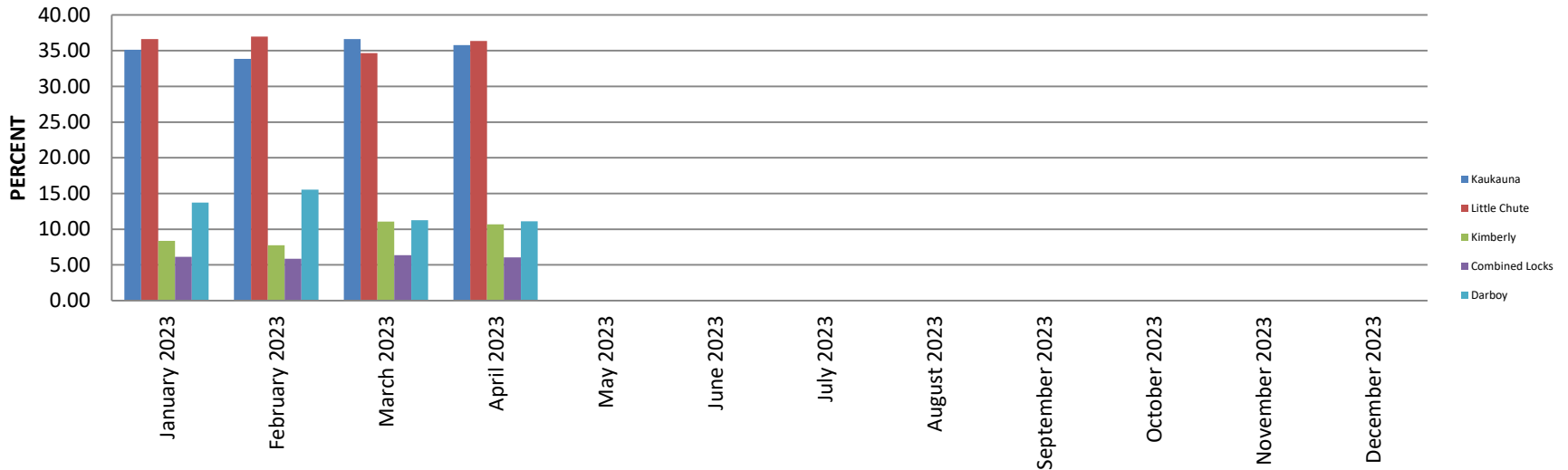

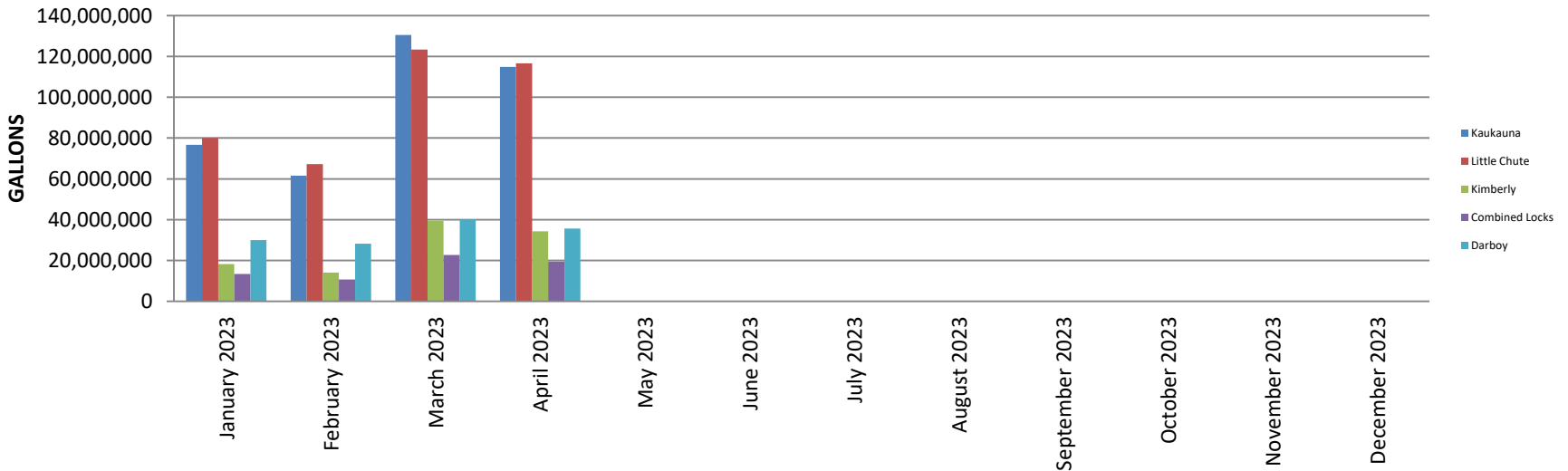

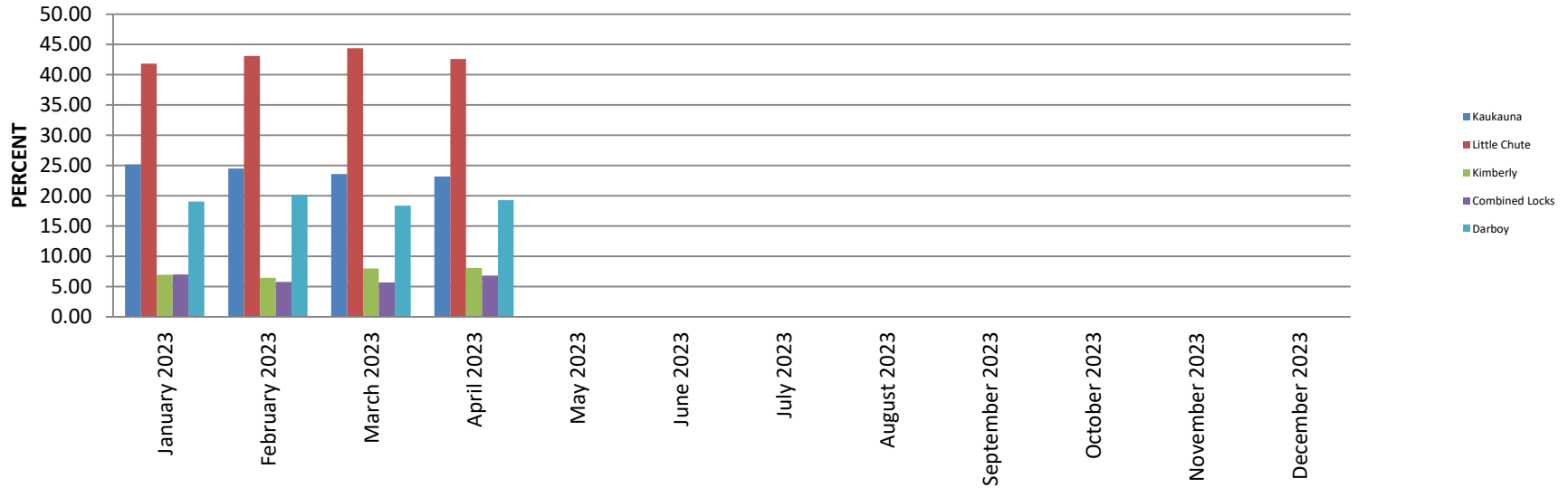

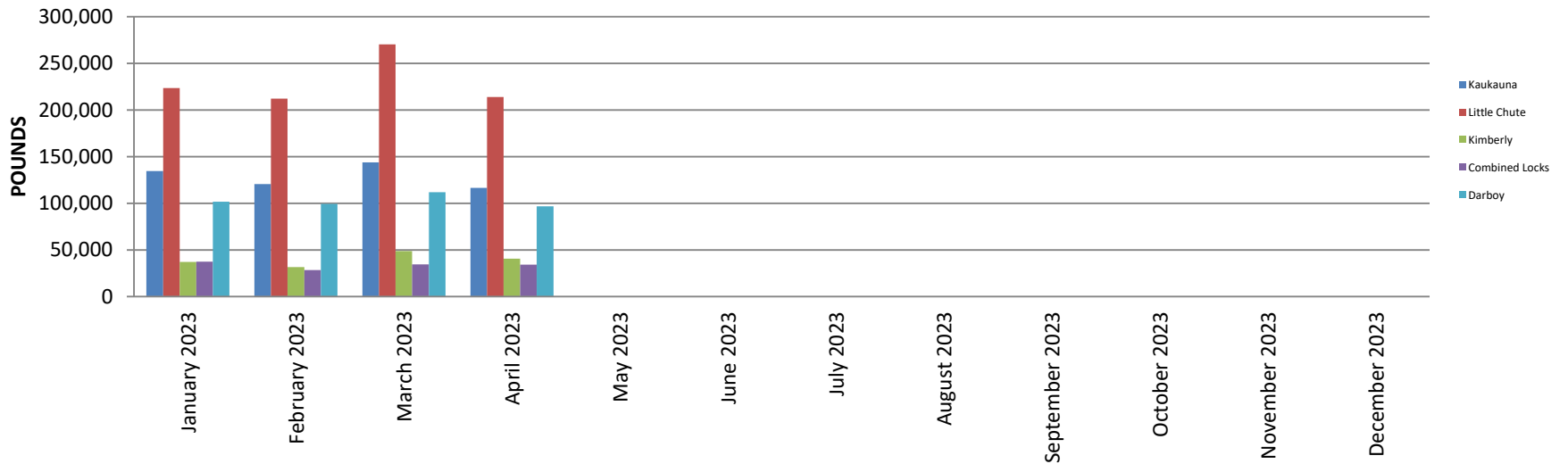

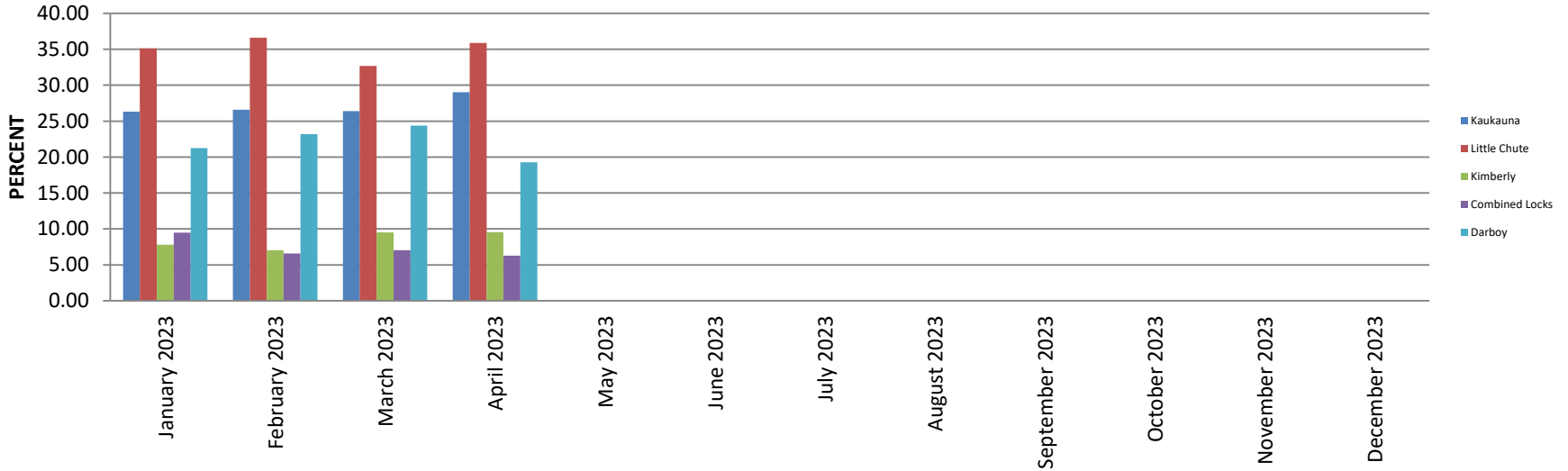

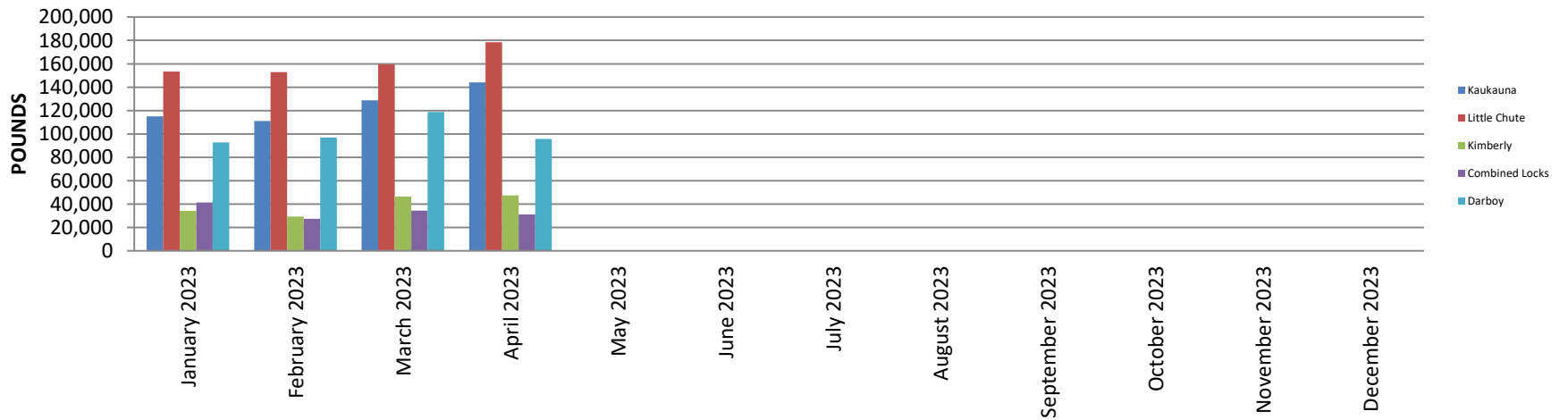

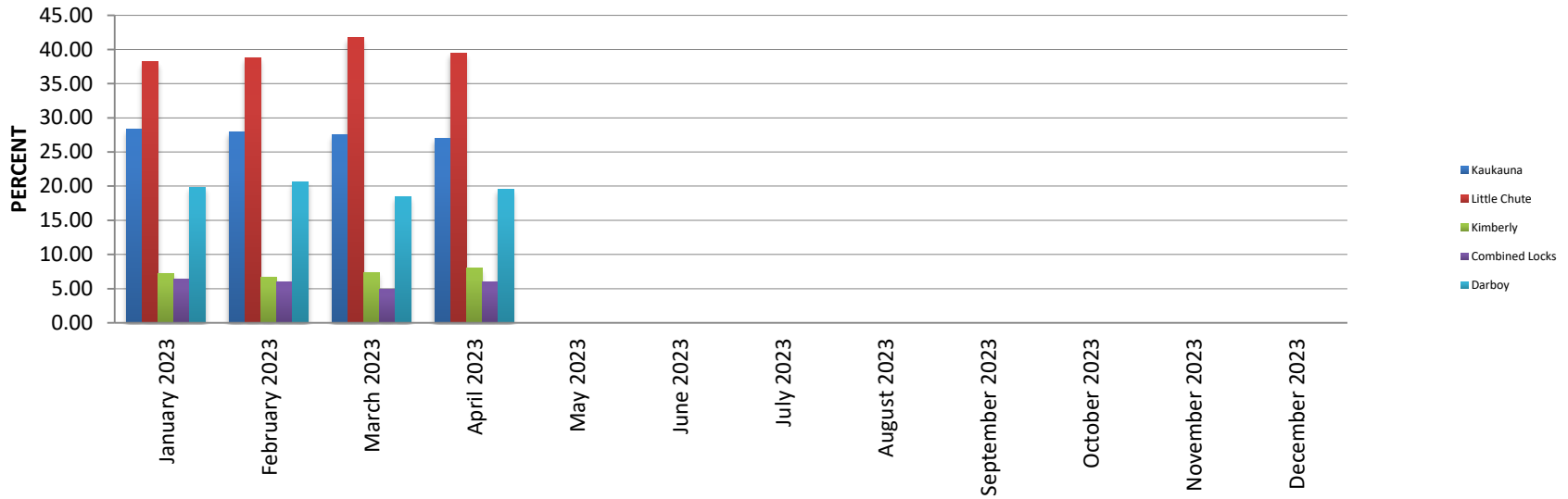

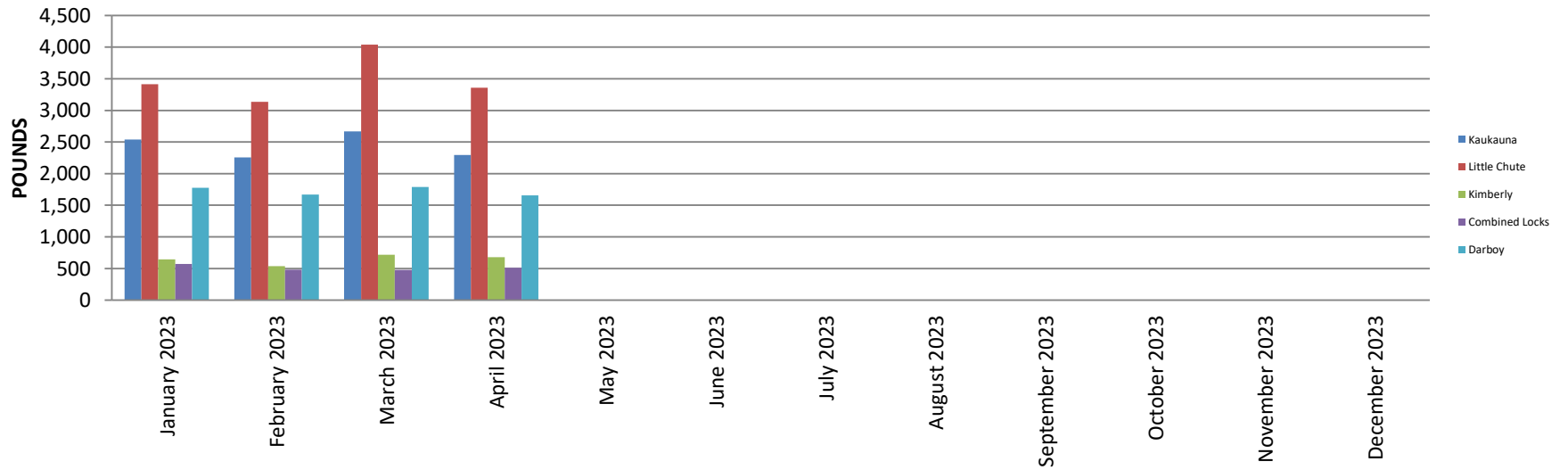

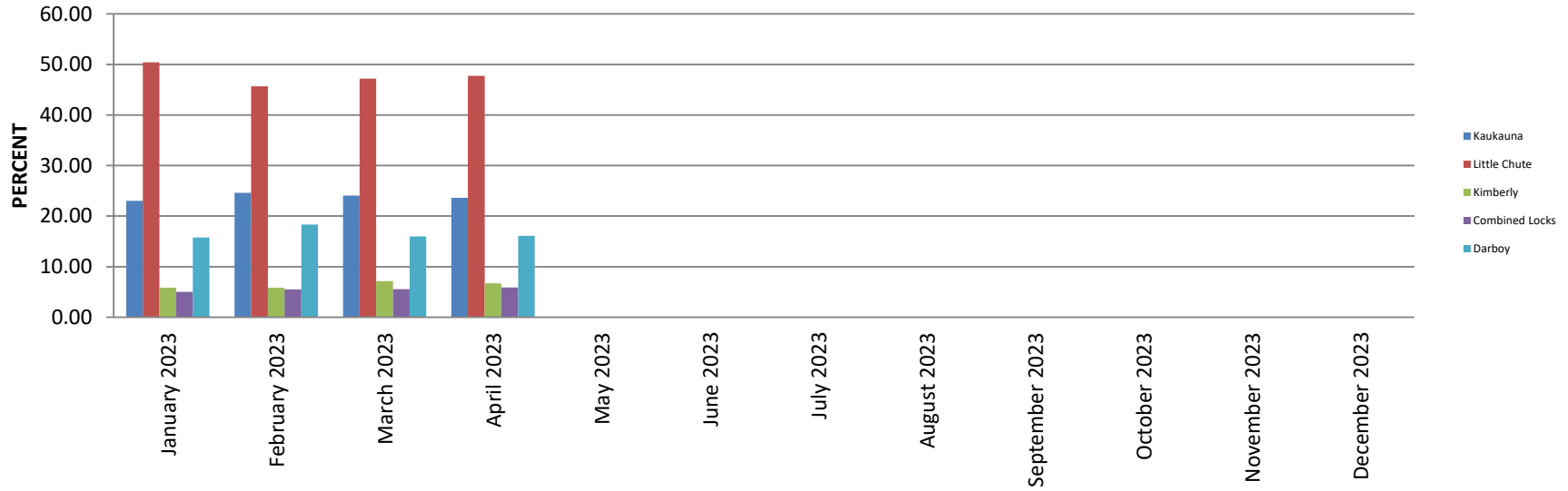

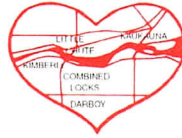
