HOVMSD FOG Control Program Update

June 2023

Darboy Sanitary District: Mr. Brews Taphouse opened on the old Darboy Club site. We visited the site in late June and the manager in charge of the trap maintenance was not on site. We will revisit them in July. Four reminder letters are required and 2 site visits will be conducted.

Village of Combined Locks: There were no significant issues, related to the FOG Control Program, in June. No reminder letters are required and 1 site visit will be conducted.

Village of Kimberly: Timber Tap is open during evening hours only and we have not yet been able to get there for a site inspection. The facility has a grease trap and, according to their Facebook page, food service is very limited. When we visit, we will ask them to clean the trap after a year and modify their schedule accordingly. No reminder letters are required and 1 site visit will need to be conducted`.

Village of Little Chute: Fox Valley Meal Prep recently opened on Main Street. We stopped in to inspect their facility and introduce them to the FOG Control Program. Two reminder letters are required and no site visits will need to be conducted.

City of Kaukauna: There were no significant issues, related to the FOG Control Program, in June. A total of 4 reminder letters are required and no site visits will need to be conducted.

Summary of Site Visits & Correspondence

Olive Garden, Red Robin, SALT, China Garden, Mac's/Pizza Ranch, Thai Sushi, Ban Vinai, Walmart and Novo Grande: On or around June 9. 2023, the grease traps or downstream manholes for all of the above-named locations were checked. All of the grease traps or manholes were in good condition.

A&W, **Arby's**, **Chipotle**, **Dunkin**, **Jersey Mikes**, **Panda Express**, **Panera Bread**, **Papa Johns**, **Papa Murphys**, **Starbucks and Tulum**: On or around June 18, 2023, the exterior traps at the above listed locations were checked. Subway: On June 29, 2023, we met again with the manager of Subway and he said the trap was cleaned around mid-June but all slips are routed to corporate. He will try to get us a copy.

Mr. Brews Taphouse: On June 29, 2023, we stopped at the recently opened Mr. Brews Taphouse to introduce the FOG Control Program. The manager who would have oversite of the cleanings and submittals was not there and they asked us to stop back to talk to them. We will do so in July.
