# August 2023

**Darboy Sanitary District**: As in the past, the facilities that are habitually non-compliant are also those served by Sanimax. While the inability to get documentation from Sanimax directly causes some issues, we do send notices to the affected businesses and give them a month to track down the paperwork. Most do nothing until we visit them personally. This was again the case with Noodles & Co. and Pick N Save. The issue is how far to push a business that is doing the work, but not fulfilling the paperwork submittal requirements. And with the continues management turnover at the big chains, there may not be a better solution. One reminder letter is required and 6 site visits will be conducted.

**Village of Combined Locks**: There were no significant issues, related to the FOG Control Program, in August. Three reminder letters are required and no site visits will be conducted.

**Village of Kimberly**: There were no significant issues, related to the FOG Control Program, in August. One reminder letter is required and one site visit will need to be conducted`.

**Village of Little Chute**: There were no significant issues, related to the FOG Control Program, in August. Two reminder letters are required and 5 site visits will need to be conducted.

**City of Kaukauna**: We were unable to make contact with the personnel at Prime Steer and 313 Dodge because of their business hours. We will visit them in the afternoon sometime in early September. A total of 7 reminder letters are required and 6 site visits will need to be conducted.
