**Darboy Sanitary District**: The A&W Restaurant is past due for their exterior trap cleaning. We have monitored this site over time and found it was in need of cleaning in August. A reminder letter was sent and ignored, in early August. Ownership has been somewhat hostile in the past, so we will make contact immediately to get the cleaning process rolling. Two reminder letters are required and 2 site visits will be conducted.

**Village of Combined Locks**: There were no significant issues, related to the FOG Control Program, in September. No reminder letters are required and 2 site visits will be conducted.

**Village of Kimberly**: There were no significant issues, related to the FOG Control Program, in August. Five reminder letters are required and one site visit will need to be conducted`.
