Darboy Sanitary District: There were no significant issues, related to the FOG Control Program, in January. Two reminder letters are required and two site visits will be conducted.

Village of Combined Locks: After being introduced to the FOG Control Program in November, the new owners of the LOX Club remain non-compliant through January. We stopped in again to make sure they received the FOG Control Program information, but again were only able to talk to staff. We are awaiting the monthly contractor reports to see if they are on the list. No reminder letters are required and 1 site visit will be conducted.

Village of Kimberly: There were no significant issues, related to the FOG Control Program, in January. Three reminder letters are required and 2 site visits will need to be conducted`.

Village of Little Chute: Landreman's was invited to the February Commission meeting to address their chronic non-compliance. The owner is now involved and has assured us that they will clean and report, as required. Everlasting Hall has still not responded to our requests to clean or verify the cleaning of their grease trap. We will continue to monitor the site and leave messages until we can determine if the trap has been cleaned. One reminder letter is required and 4 site visits will need to be conducted.

City of Kaukauna: Jimmy John's and Hilltop Bakery were visited and both sites were cleaning their traps on schedule, but ran into reporting issues. Jimmy John's was due to employee forgetfulness and Hilltop Bakery due to contractor forgetfulness. One reminder letter is required and 1 site visit will need to be conducted.

Summary of Site Visits & Correspondence

Landreman's Restaurant: In early January, we sent Landreman's Restaurant a letter inviting a representative to the next HOVMSD Commission meeting to explain their chronic defiance of the reporting requirements of the FOG Control Program. The consistent response to our inquiries was always, "we clean the trap weekly, but forget to let you know." In which we would respond, "If you can't remember to report, how can we be assured that you remember to clean?" Unable to come to any consensus on that matter, we felt they could present their reasoning to the Commission and see where that took them.

As with most invites to Commission meetings, this one got the attention of the owner. Upon receipt of our letter, he immediately called to see what could be done to rectify the situation and avoid an appearance before the Commission. We informed him that cleaning on schedule and reporting shortly thereafter is our simple expectation. He seemed agreeable and within hours of our conversation, a cleaning report was texted to us. While we allowed him to skip the February Commission meeting, we told him that the invite would not be rescinded again, if he failed to submit his reports going forward. The next report is due the 1st week of February.

Celebration Gourmet: On January 23, 2024, we stopped in at Celebration Gourmet and were informed that Speedy Clean does their cleaning and should have reported it directly to us. We checked with Speedy Clean and made sure that Celebration is included on their monthly updates from now on.

Everlasting Hall: We again did not receive a response from Everlasting Hall (former 5th Quarter) in regards to cleaning their trap. The trap cover was either secured or frozen down when we tried to do a manual inspection. We did leave a message for the caretaker and did not hear back.
