March 2024

Darboy Sanitary District: We performed inspections of the exterior traps on several of the sites in which we have had a hard time getting the cleaning information from their corporate owners. With the exception of A&W, all of the traps were in good condition. Five reminder letters are required and three site visits will be conducted.

Village of Combined Locks: We were able to get into the Lox Club, just as they opened and talked to the new owners about the FOG Control Program before they got too busy. They had a service clean the trap in early March and now have our contact information to provide the documentation going forward. No reminder letters are required and no site visits will be conducted.

Village of Kimberly: There were no significant issues, related to the FOG Control Program, in Kimberly during March. One reminder letter is required and 1 site visit will need to be conducted`.

Village of Little Chute: The owners of Everlasting Hall did not clean their exterior trap in March, citing the need for warm weather. A late month inspection of the trap showed it was well past due and probably allowing grease to bypass into the municipal sewer. If the owner doesn't clean the trap by early April, we will look at placarding the site and pursuing a more punitive path to gain their compliance. No reminder letters are required and 1 site visit will need to be conducted.

City of Kaukauna: Ther former Mariner property has reopened as a dance club/music venue. The site seems to be open only sporadically, making contacting anyone, to determine what services are offered, difficult. Five reminder letters are required and 2 site visits will need to be conducted.
