# April 2024

**Darboy Sanitary District**: The A&W Store pumped their trap several days after we visited the site to discuss their non-compliance. We are checking their grease trap more frequently to see if they need to increase their cleaning frequency. Five reminder letters are required and four site visits will be conducted.

**Village of Combined Locks**: There were no significant issues, related to the FOG Control Program, in April. Two reminder letters are required and no site visits will be conducted.

**Village of Kimberly**: There were no significant issues, related to the FOG Control Program, in April. Four reminder letters are required and no site visit will need to be conducted`.

**Village of Little Chute**: The owners of Everlasting Hall finally cleaned their trap in early April. Landreman's Restaurant is again non-compliant. The new owners assured us that the days of chronic non-compliance were over. We'll sit down with them and see why it is again a problem. Six reminder letters are required and 1 site visit will need to be conducted.

**City of Kaukauna**: Patty and Pablos opened up in the former Sticky Fingers location. We visited the site and dropped off information on the requirements of the FOG Control Program. Three reminder letters are required and four site visits will need to be conducted.

#### Summary of Site Visits & Correspondence

**Red Robin, SALT, China Garden, Mac's/Pizza Ranch, Thai Sushi, Ban Vinai, Tulum, Walmart and Novo Grande:** On or around April, 11, 2024, the grease traps or downstream manholes for all of the above-named locations were checked. All of the grease traps or manholes were in good condition.
