Darboy Sanitary District: There were no significant issues, related to the FOG Control Program, in May. Three reminder letters are required and no site visits need to be conducted.

Village of Combined Locks: There were no significant issues, related to the FOG Control Program, in May. One reminder letter is required and one site visit will be conducted.

Village of Kimberly: There were no significant issues, related to the FOG Control Program, in May. One reminder letter is required and three site visits will need to be conducted`.

Village of Little Chute: Landreman's Restaurant was invited to the May Commission meeting to explain their chronic non-compliance. The owner met with us and vowed to solve the problem with their cleaning and reporting, with the understanding that any future non-compliance issue will lead to a fast-track Commission meeting invite. City of Kaukauna: During our site visit to Sweet Treats to discuss their grease trap cleaning, we discovered that the grease trap had been removed during renovations.
