Darboy Sanitary District: Mac's Maccaroni is consistently non-compliant because of the constant staff turnover and Sanimax's refusal to easily provide access to their cleaning documents. This is an ongoing problem in all the Program Communities and one in which we still have not been able to creatively solve. Eight reminder letters are required and five site visits will need to be conducted.

Village of Combined Locks: There were no significant issues, related to the FOG Control Program, in August. No reminder letters are required and no site visits will be conducted.

Village of Kimberly: The remodeling of the former Mom and Pop's Bakery continues. We will monitor the progress and introduce the FOG Control Program to the new operators when they are ready to open. Two reminder letters are required and no site visits will need to be conducted`.

Village of Little Chute: There were no significant issues, related to the FOG Control Program, in August. Five reminder letters are required and two site visits will need to be conducted.

City of Kaukauna: All of the Kaukauna Area School District sites are overdue for submittal of their cleaning documents. This is normally a paperwork issue and causes the number of non-compliant sites to appear significantly higher for that one month a year that we deal with this. We will email the director of facilities and the issue should be resolved early in September. Eight reminder letters are required and three site visits will need to be conducted. One site is in the process of installing a grease trap.

Cake Anatomy: On August 29, 2024, we stopped at Cake Anatomy and the store was closed. We left a message at the phone number listed on the door and have not heard back yet.

She indicated that the trap is cleaned by different persons each week and they usually forget to text after the cleaning. She will try to put a better system in place to make sure we are notified.
