Darboy Sanitary District: The usual issues with Sanimax serviced businesses surfaced again in July. The Royal Event remains closed while the Darboy Shell and Uncle Mikes Kringle shop prepare to open. Five reminder letters are required and three site visits will need to be conducted.

Village of Combined Locks: There were no significant issues, related to the FOG Control Program, in July. Two reminder letters are required and no site visits will be conducted.

Village of Kimberly: There were no significant issues, related to the FOG Control; Program, In July. Three sites will require reminder letters and one site visit will need to be conducted.

Village of Little Chute: The owner of China Moon insists that she is sending us cleaning reports, yet we have been unable to find any that were sent. When we do a site visit she shows us the document that she says she texted. This is the only site in which this has been a problem. Three reminder letters are required and one site visit will need to be conducted.

City of Kaukauna: Sweet Treats has installed their trap. Cake Anatomy has indicated they have moved near their old storefront, but has not disclosed an address. A new tenant is rumored to be ready to move into the old Cake Anatomy site, but we cannot verify what type of business is coming in. Two reminder letters are required and one site visit will need to be conducted. .

Summary of Site Visits & Correspondence

Cake Anatomy: The Cake Anatomy site is now empty and there is no indication on their Facebook page as to where they have relocated. An article in *The Villager* teased another business taking over the building, but did not indicate what type of business was coming.

Prime Steer: On July 31, 2025, we stopped at Prime Steer and no one was on site. We manually checked the exterior trap and found that it had recently been cleaned.

Sweet Treats: On July 31, 2025, we documented the installation of the new grease trap at Sweet Treats. After a year, we will revisit the site and work with them in establishing a cleaning schedule.

Skyview Club: Several times over the course of the month we drove by the Skyview Club in the early afternoon. We had no luck finding anyone on site to verify that they received our FOG Control Program introduction packet. We will send them a reminder letter and try to set up an appointment to go over the requirements of the Program.
