HOVMSD FOG Control Program Update

December 2025

Darboy Sanitary District: Lamers Dairy has installed a 5,000-gallon grease interceptor to address FOG issues they have had with the HOV Pretreatment Program. Grand Central Station opened on the former Darboy Club site and will feature a convenience store Dunkin, Godfather's Pizza and carwash. Five reminder letters are required and five site visits will need to be conducted.

Village of Combined Locks: There were no significant issues, related to the FOG Control Program, in December. No reminder letters are required and no site visits will be conducted.

Village of Kimberly: December saw the closing of Anduzzis and Casa Rivera. Anduzzis is for sale and could return as a restaurant. The fate of Casa Rivera is uncertain. Two reminder letters are required and no site visits will need to be conducted.

Village of Little Chute: With the exception of Piggly Wiggly not sending over their cleaning documents, there were no significant issues, related to the FOG Control Program, in December. Three reminder letters are required and one site visit will need to be conducted.

City of Kaukauna: There were no significant issues, related to the FOG Control Program, in December. Three reminder letters are required and two site visits will need to be conducted.

Summary of Site Visits & Correspondence

Olive Garden, Red Robin, China Garden, Mac's/Pizza Ranch, Thai Sushi, Tulum, Walmart and Novo Grande: On or around December 16, 2025, the grease traps or downstream manholes for all of the above-named locations were checked. All of the grease traps or manholes were in good condition.

Lamers Dairy: Lamers Dairy installed a 5,000-gallon grease interceptor on their process discharge line. They are initially looking at cleaning the interceptor every 6 months and will adjust as needed.

Grand Central Station: Grand Central Station opened at the end of December on the old Darboy Club site. They have an exterior interceptor that serves their business as well as the Dunkin store and Godfather's Pizza. We will visit the site in January to introduce them to the FOG Control Program.

IVR Bar: On December 16. 2025, we stopped at the IVR Bar and inquired about their last trap cleaning. The bartender said the owner would get right back to us. To date, we haven't received a response.

Thai Sushi: On December 16, 2025, we checked the exterior interceptor at Thai Sushi. It appears to have been cleaned recently.

Royal Event: On December 16, 2025, we met with the owners of Royal Event. They are not to a point of re-opening and thus have not been putting any grease into their grease trap.
